# An extremal composition operator on the Hardy space of the bidisk with small approximation numbers

#### Abstract

We construct an analytic self-map $\Phi$ of the bidisk $\mathbb{D}^{2}$ whose image touches the distinguished boundary, but whose approximation numbers of the associated composition operator on $H^{2}\left(\mathbb{D}^{2}\right)$ are small in the sense that $\lim \sup _{n \rightarrow \infty}\left[a_{n^{2}}\left(C_{\Phi}\right)\right]^{1 / n}<1$.

## 1 Introduction

For composition operators $C_{\Phi}: H^{2}(\mathbb{D}) \rightarrow H^{2}(\mathbb{D})$ on the Hardy space of the unit disk, the decay of their approximation numbers $a_{n}\left(C_{\Phi}\right)$ cannot be arbitrarily fast, and actually cannot supersede a geometric speed ([16]; see also [10, Theorem 3.1]): there exists a positive constant $c$ such that:

$$
a_{n}\left(C_{\Phi}\right) \gtrsim \mathrm{e}^{-c n}, \quad n=1,2, \ldots
$$

It is easy to see that this speed occurs when $\|\Phi\|_{\infty}<1$, and we proved in [10, Theorem 3.4] that a geometrical speed only takes place in this case; in other words:

$$
\begin{equation*}
\|\Phi\|_{\infty}=1 \quad \Longleftrightarrow \quad \lim _{n \rightarrow \infty}\left[a_{n}\left(C_{\Phi}\right)\right]^{1 / n}=1 \tag{1.1}
\end{equation*}
$$

This leads to the introduction, for an operator $T$ between Banach spaces, of the parameters:

$$
\begin{equation*}
\beta^{-}(T)=\liminf _{n \rightarrow \infty}\left[a_{n}(T)\right]^{1 / n} \quad \text { and } \quad \beta^{+}(T)=\limsup _{n \rightarrow \infty}\left[a_{n}(T)\right]^{1 / n}, \tag{1.2}
\end{equation*}
$$

where $a_{n}(T)$ is the $n$-th approximation number of $T$. When $\left[a_{n}(T)\right]^{1 / n}$ actually has a limit, i.e. when $\beta^{-}(T)=\beta^{+}(T)$, we write it $\beta(T)$.

What is proved in [10, Theorem 3.4] is that $\beta\left(C_{\Phi}\right)=1$ if and only if $\|\Phi\|_{\infty}=1$. Later, in [12], we gave, when $\|\Phi\|_{\infty}<1$, a formula for this parameter in terms of the Green capacity of $\Phi(\mathbb{D})$, which allowed us to recover (1.1).

More generally, for $N \geq 1$, we introduce:

$$
\begin{equation*}
\beta_{N}^{-}(T)=\liminf _{n \rightarrow \infty}\left[a_{n^{N}}(T)\right]^{1 / n} \quad \text { and } \quad \beta_{N}^{+}(T)=\limsup _{n \rightarrow \infty}\left[a_{n^{N}}(T)\right]^{1 / n} \tag{1.3}
\end{equation*}
$$

and:

$$
\begin{equation*}
\beta_{N}(T)=\lim _{n \rightarrow \infty}\left[a_{n^{N}}(T)\right]^{1 / n} \tag{1.4}
\end{equation*}
$$

when the limit exists. It is clear that $0 \leq \beta_{N}^{ \pm}(T) \leq 1$, and it is interesting to know when the extreme cases $\beta_{N}^{ \pm}(T)=0$ or $\beta_{N}^{ \pm}(T)=1$ occur. For example:

$$
\begin{array}{lll}
\beta_{N}^{-}(T)>0 & \Longleftrightarrow & a_{n^{N}}(T) \gtrsim \mathrm{e}^{-\tau n},
\end{array} \quad \text { with } \tau>0, ~ 子 a_{n}(T) \gtrsim \mathrm{e}^{-n \varepsilon_{n}}, \quad \text { with } \varepsilon_{n} \rightarrow 0 .
$$

It is coined in [1] (see also [13] and [14]) that $\beta_{N}^{ \pm}\left(C_{\Phi}\right)$ are the suitable parameters for the composition operators on $H^{2}\left(\mathbb{D}^{N}\right)$, and it is proved, for any $N \geq 1$, that $\beta_{N}^{-}\left(C_{\Phi}\right)>0$, as soon as $\Phi$ is non degenerate (i.e. the Jacobian $J_{\Phi}$ is not identically 0 ) and the operator $C_{\Phi}$ is bounded on $H^{2}\left(\mathbb{D}^{N}\right)$. As for an expression of $\beta_{N}^{ \pm}\left(C_{\Phi}\right)$ in terms of "capacity", only partial results are known so far ([13] and [14]) and the application to a result like (1.1) fails in general. We gave an example of such a phenomenon in [13, Theorem 5.12]. In the present paper we give a shaper result.

## 2 Background and notation

Let $\mathbb{D}$ be the open unit disk, $H^{2}\left(\mathbb{D}^{N}\right)$ the Hardy space of the polydisk $\mathbb{D}^{N}$, and $\Phi: \mathbb{D}^{N} \rightarrow \mathbb{D}^{N}$ an analytic map. When $N=1$, it is well-known (see [4] or [17]) that $\Phi$ induces a composition operator $C_{\Phi}: H^{2}(\mathbb{D}) \rightarrow H^{2}(\mathbb{D})$ by the formula:

$$
C_{\Phi}(f)=f \circ \Phi,
$$

and the connection between the "symbol" $\Phi$ and the properties of the operator $C_{\Phi}$, in particular its compactness, can be further studied (see [4] or [17]). When $N>1, C_{\Phi}$ is not bounded in general (see [4]).

Let $\mathbb{T}$ be the unit circle, and $m$ the normalized Haar measure on $\mathbb{T}^{N}$. A positive Borel measure $\mu$ on $\mathbb{D}^{N}$ is called a Carleson measure (for the space $H^{2}\left(\mathbb{D}^{N}\right)$ ) if the canonical injection $J: H^{2}\left(\mathbb{D}^{N}\right) \rightarrow L^{2}(\mu)$ is bounded. When $\Phi: \mathbb{D}^{N} \rightarrow \mathbb{D}^{N}$ is analytic and induces a bounded composition operator on $H^{2}\left(\mathbb{D}^{N}\right)$, the pullback measure $m_{\Phi}=\Phi^{*}(m)$, defined, for any test function $u$, by:

$$
\int_{\mathbb{D}^{N}} u(w) d m_{\Phi}(w)=\int_{\mathbb{T}^{N}} u\left[\Phi^{*}(\xi)\right] d m(\xi)
$$

is a Carleson measure. Here $\Phi^{*}$ is the radial limit function, defined for $m$ almost every $\xi \in \mathbb{T}^{N}$, by $\Phi^{*}(\xi)=\lim _{r \rightarrow 1^{-}} \Phi(r \xi)$.

For $\xi \in \mathbb{T}=\partial \mathbb{D}$ and $h>0$, the Carleson window $S(\xi, h)$ is defined as:

$$
\begin{equation*}
S(\xi, h)=\{z \in \mathbb{D} ;|z-\xi| \leq h\} \tag{2.1}
\end{equation*}
$$

If $f \in \operatorname{Hol}\left(\mathbb{D}^{2}\right), D_{j}^{k} f$ denotes the $k$-th derivative of $f$ with respect to the $j$-th variable $(j=1,2)$.

We denote by $A(\mathbb{D})$ the disk algebra, i.e. the space of functions holomorphic in $\mathbb{D}$ and continuous on $\overline{\mathbb{D}}$. We similarly define the bidisk algebra $A\left(\mathbb{D}^{2}\right)$.

Let $H_{1}$ and $H_{2}$ be Hilbert spaces, and $T: H_{1} \rightarrow H_{2}$ an operator. The $n$-th approximation number $a_{n}(T)$ of $T, n=1,2, \ldots$, is defined (see [2]) as the distance (for the operator-norm) of $T$ to operators of rank $<n$ :

$$
\begin{equation*}
a_{n}(T)=\inf _{\operatorname{rank} R<n}\|T-R\| \tag{2.2}
\end{equation*}
$$

The approximation numbers have the ideal property:

$$
a_{n}(A T B) \leq\|A\| a_{n}(T)\|B\|
$$

The $n$-th Gelfand number $c_{n}(T)$ of $T$ is defined by:

$$
\begin{equation*}
c_{n}(T)=\inf _{\operatorname{codim} E<n}\left\|T_{\mid E}\right\| \tag{2.3}
\end{equation*}
$$

As an easy consequence of the Schmidt decomposition, we have for any compact operator between Hilbert spaces:

$$
\begin{equation*}
c_{n}(T)=a_{n}(T) \tag{2.4}
\end{equation*}
$$

If $T, T_{1}, T_{2}: H \rightarrow H^{\prime}$ are operators between Hilbert spaces $H$ and $H^{\prime}$, we write $T=T_{1} \oplus T_{2}$ if $T=T_{1}+T_{2}$ and:

$$
\|T x\|^{2}=\left\|T_{1} x\right\|^{2}+\left\|T_{2} x\right\|^{2}, \quad \text { for all } x \in H
$$

The subaddivity of approximation numbers is then expressed by:

$$
\begin{equation*}
a_{j+k}\left(T_{1} \oplus T_{2}\right) \leq a_{j}\left(T_{1}\right)+a_{k}\left(T_{2}\right) \tag{2.5}
\end{equation*}
$$

We denote by $\mathbb{N}=\{0,1,2, \ldots\}$ the set of non-negative integers, and by $[x]$ the integral part of the real number $x$.

We write $X \lesssim Y$ to indicate that $X \leq c Y$ for some constant $c>0$, and $X \approx Y$ to indicate that $X \lesssim Y$ and $Y \lesssim X$.

## 3 Purpose of the paper

Let us recall that the Hardy space of the polydisk is the space:

$$
H^{2}\left(\mathbb{D}^{N}\right)=\left\{f: \mathbb{D}^{N} \rightarrow \mathbb{C} ; f(z)=\sum_{\alpha \in \mathbb{N}^{N}} a_{\alpha} z^{\alpha} \text { and }\|f\|_{2}^{2}:=\sum\left|a_{\alpha}\right|^{2}<\infty\right\}
$$

If $\Phi: \mathbb{D}^{N} \rightarrow \mathbb{D}^{N}$ is an analytic map, the associated composition operator $C_{\Phi}\left(\right.$ which is not always bounded on $\left.H^{2}\left(\mathbb{D}^{N}\right)\right)$ is defined by:

$$
C_{\Phi}(f)=f \circ \Phi .
$$

We will mainly here be interested in the case $N=2$.
The reproducing kernel $K_{a}$ of $H^{2}\left(\mathbb{D}^{2}\right)$ is, with $a=\left(a_{1}, a_{2}\right)$ and $z=$ $\left(z_{1}, z_{2}\right)$ :

$$
\begin{equation*}
K_{a}(z)=\frac{1}{\left(1-\overline{a_{1}} z_{1}\right)\left(1-\overline{a_{2}} z_{2}\right)} . \tag{3.1}
\end{equation*}
$$

As a consequence:

$$
\begin{equation*}
|f(a)|=\left|\left\langle f, K_{a}\right\rangle\right| \leq \frac{\|f\|_{2}}{\sqrt{\left(1-\left|a_{1}\right|^{2}\right)\left(1-\left|a_{2}\right|^{2}\right)}} \tag{3.2}
\end{equation*}
$$

In particular, the functions in the unit ball of $H^{2}\left(\mathbb{D}^{2}\right)$ are uniformly bounded on compact subsets of $\mathbb{D}^{2}$.

In [13, Theorem 5.12], we gave an example of a holomorphic self-map $\Phi: \mathbb{D}^{2} \rightarrow \mathbb{D}^{2}$, continuous on the closure $\overline{\mathbb{D}^{2}}$, such that $\|\Phi\|_{\infty}=1$, that is:

$$
\begin{equation*}
\Phi\left(\mathbb{T}^{2}\right) \cap \partial \mathbb{D}^{2} \neq \emptyset \tag{3.3}
\end{equation*}
$$

and yet:

$$
\begin{equation*}
\beta_{2}^{+}\left(C_{\Phi}\right)<1, \tag{3.4}
\end{equation*}
$$

in contrast with the one-dimensional case ([10, Theorem 3.4]).

Understanding where the difference really lies when we pass to the multidimensional case is a big challenge: it does not seem to be a matter of regularity of the boundary, and a similar example probably holds for the Hardy space of the ball. It might be a matter of boundary: the Shilov boundary of the ball is its usual boundary, but that of the polydisk is its distinguished boundary:

$$
\partial_{e} \mathbb{D}^{N}=\left\{z=\left(z_{j}\right) ;\left|z_{j}\right|=1 \text { for all } j=1, \ldots, N\right\}=\mathbb{T}^{N}
$$

(indeed, the distinguished maximum principle tells that, for $f$ analytic in $\mathbb{D}^{N}$ and continuous on $\overline{\mathbb{D}^{N}}$, it holds $\left.\max _{z \in \mathbb{D}^{N}}|f(z)|=\max _{z \in \partial_{e} \mathbb{D}^{N}}|f(z)|\right)$. The aim of this paper is to show that this is not the case and, improving on $\left(\left[13\right.\right.$, Theorem 5.12]) and (3.3), to build an analytic self-map $\Phi: \mathbb{D}^{2} \rightarrow \mathbb{D}^{2}$, continuous on $\overline{\mathbb{D}^{2}}$, non-degenerate and such that:

$$
\begin{equation*}
\Phi\left(\mathbb{T}^{2}\right) \cap \partial_{e} \mathbb{D}^{2} \neq \emptyset, \quad \text { but } \quad \beta_{2}^{+}\left(C_{\Phi}\right)<1 \tag{3.5}
\end{equation*}
$$

The paper is organized as follows. In Section 4, we recall with some detail the definition and main properties of a so-called cusp map $\chi \in A(\mathbb{D})$, to be of essential use in our counterexample. In Section 5 , we prove several lemmas which constitute the core or the proof. In Section 6, we state and prove our main theorem.

## 4 The cusp map

The cusp map $\chi: \mathbb{D} \rightarrow \mathbb{D}$ is analytic in $\mathbb{D}$ and extends continuously on $\overline{\mathbb{D}}$. The boundary of its image is formed by three circular arcs of respective centers $\frac{1}{2}, 1+\frac{i}{2}, 1-\frac{i}{2}$, and of radius $\frac{1}{2}$ (see Figure 1). However, the parametrization $t \mapsto \chi\left(\mathrm{e}^{i t}\right)$ involves logarithms.

It was often used by the authors ([11], [8]) as an extremal example.
We first recall the definition of $\chi$.
Let $\mathbb{D}^{+}=\{z \in \mathbb{D} ; \mathfrak{R e} z>0\}$ be the right half-disk. Let now $\mathbb{H}$ be the upper half-plane, and $T: \mathbb{D} \rightarrow \mathbb{H}$ defined by:

$$
T(u)=i \frac{1+u}{1-u}, \quad \text { with } \quad T^{-1}(s)=\frac{s-i}{s+i}
$$

Taking the square root of $T$, we map $\mathbb{D}$ onto the first quadrant defined by $Q_{1}=\{z \in \mathbb{C} ; \mathfrak{R e} z>0\} ;$ we go back to the half-disk $\{z \in \mathbb{D} ; \mathfrak{I m} z<0\}$ by $T^{-1}$. Finally, make a rotation by $i$ to go onto $\mathbb{D}^{+}$. We get:

$$
\chi_{0}(z)=\frac{\left(\frac{z-i}{i z-1}\right)^{1 / 2}-i}{-i\left(\frac{z-i}{i z-1}\right)^{1 / 2}+1}
$$



Figure 1: Cusp map domain

One has $\chi_{0}(1)=0, \chi_{0}(-1)=1, \chi_{0}(i)=-i$, and $\chi_{0}(-i)=i$. The half-circle $\{z \in \mathbb{T} ; \mathfrak{R e} z \geq 0\}$ is mapped by $\chi_{0}$ onto the segment $[-i, i]$ and the segment $[-1,1]$ onto the segment $[0,1]$.

Set now, successively:

$$
\begin{equation*}
\chi_{1}(z)=\log \chi_{0}(z), \quad \chi_{2}(z)=-\frac{2}{\pi} \chi_{1}(z)+1, \quad \chi_{3}(z)=\frac{1}{\chi_{2}(z)} \tag{4.1}
\end{equation*}
$$

and finally:

$$
\begin{equation*}
\chi(z)=1-\chi_{3}(z) . \tag{4.2}
\end{equation*}
$$

We now summarize the properties of the cusp map $\chi$ in the following proposition.

Proposition 4.1. The cusp map satisfies:

1) $1-|\chi(z)| \lesssim \frac{1}{\log (2 /|1-z|)}$;
2) $|1-\chi(z)| \leq K(1-|\chi(z)|)$ for all $z \in \mathbb{D}$, where $K$ is a positive constant;
3) $\chi(\mathbb{D})$ is the intersection of the open disk $D\left(\frac{1}{2}, \frac{1}{2}\right)$ with the exterior of the two open disks $D\left(1+\frac{i}{2}, \frac{1}{2}\right)$ and $D\left(1-\frac{i}{2}, \frac{1}{2}\right)$;
4) $\chi(1)=1, \chi(\bar{z})=\overline{\chi(z)}$ and $|\chi(z)-1| \leq 1$ for all $z \in \mathbb{D}$;
5) for $0<|t| \leq \pi / 4$, we have $1-\mathfrak{R e} \chi\left(\mathrm{e}^{i t}\right) \approx 1 /(\log 1 /|t|)$;
6) $\chi(\overline{\mathbb{D}}) \subseteq\left\{z=x+i y ; 0 \leq x \leq 1\right.$ and $\left.|y| \leq 2(1-x)^{2}\right\}$.

Proof. Items 1) to 5) are proved in [11, Lemma 4.2]. To prove 6), write $\chi(z)=(1-h)+i y$. Since $\chi(\bar{z})=\overline{\chi(z)}$, we can assume $y \geq 0$. Since $\chi(\mathbb{D}) \cap D\left(1+\frac{i}{2}, \frac{1}{2}\right)=\emptyset$, we have $\left|\chi(z)-\left(1+\frac{i}{2}\right)\right| \geq \frac{1}{2}$; hence:

$$
h^{2}+\left(y-\frac{1}{2}\right)^{2}=\left|\chi(z)-\left(1+\frac{i}{2}\right)\right|^{2} \geq \frac{1}{4}
$$

so that $y \leq y^{2}+h^{2}$. But $y \leq 1 / 2$, since $\chi(z) \in D\left(\frac{1}{2}, \frac{1}{2}\right)$; therefore $y^{2} \leq y / 2$, so we get $y \leq 2 h^{2}$.

## 5 Preliminary lemmas

In this section, we collect some lemmas, which will reveal essential in the proof of our counterexample.

We consider the map $\varphi=\varphi_{\theta}, 0<\theta<1$, defined, for $z \in \overline{\mathbb{D}} \backslash\{1\}$, by:

$$
\begin{equation*}
\varphi(z)=\exp \left(-(1-z)^{-\theta}\right) . \tag{5.1}
\end{equation*}
$$

We observe, since $\mathfrak{R e}(1-z) \geq 0$ for $z \in \overline{\mathbb{D}}$, that:

$$
\begin{equation*}
|\varphi(z)| \leq \exp \left(-\delta|1-z|^{-\theta}\right) \tag{5.2}
\end{equation*}
$$

where $\delta=\cos \pi \theta / 2>0$. Moreover, (5.2) shows that $\varphi \in A(\mathbb{D})$, since:

$$
\lim _{z \rightarrow 1, z \in \mathbb{D}} \varphi(z)=0=: \varphi(1) .
$$

Our first lemma will allow us to define our symbol $\Phi$.
Lemma 5.1. One can adjust $0<c<1$ so as to get:

$$
\begin{equation*}
|\chi(z)|+2 c|\varphi \circ \chi(z)|<1 \quad \text { for all } z \in \mathbb{D} . \tag{5.3}
\end{equation*}
$$

Hence, if we set, for any $g \in A(\mathbb{D})$ with $\|g\|_{\infty} \leq 1$ :

$$
\begin{equation*}
\Phi\left(z_{1}, z_{2}\right)=\left(\chi\left(z_{1}\right), \chi\left(z_{1}\right)+c(\varphi \circ \chi)\left(z_{1}\right) g\left(z_{2}\right)\right), \tag{5.4}
\end{equation*}
$$

we have $\Phi\left(\mathbb{D}^{2}\right) \subseteq \mathbb{D}^{2}$.
Remark. The factor 2 in (5.3) is needed in order to get the following inequalities, to be used later, for $z \in \mathbb{D}$ and $w=\chi(z)+c(\varphi \circ \chi)(z) u$, with $|u| \leq 1$ :

$$
\begin{equation*}
|w| \leq \frac{1+|\chi(z)|}{2} \tag{5.5}
\end{equation*}
$$

or, equivalently:

$$
\begin{equation*}
1-|w| \geq \frac{1-|\chi(z)|}{2} \tag{5.6}
\end{equation*}
$$

Indeed:

$$
|w| \leq|\chi(z)|+c|\varphi \circ \chi(z)| \leq|\chi(z)|+\frac{1-|\chi(z)|}{2}=\frac{1+|\chi(z)|}{2} .
$$

Proof of Lemma 5.1. Set $X=|1-\chi(z)|$, so that, with $K$ the constant of Proposition 4.1, 2):

$$
\begin{equation*}
|\chi(z)| \leq 1-\frac{|1-\chi(z)|}{K}=1-\frac{X}{K} . \tag{5.7}
\end{equation*}
$$

For $z \in \mathbb{D}$ and $X$ close enough to zero, say $X<\eta$, we have $2 \exp \left(-\delta X^{-\theta}\right)<$ $\frac{X}{K}$. If we adjust $0<c<1$ so as to have $c<\frac{\eta}{2 K}$, it follows from (5.2) and (5.7) that, for $X<\eta$ :

$$
|\chi(z)|+2 c|\varphi \circ \chi(z)| \leq 1-\frac{X}{K}+2 \exp \left(-\delta X^{-\theta}\right)<1
$$

However, for $X \geq \eta$, (5.7) says that $|\chi(z)| \leq 1-\frac{\eta}{K}$, so:

$$
|\chi(z)|+2 c|\varphi \circ \chi(z)| \leq 1-\frac{\eta}{K}+2 c<1
$$

as well and this ends the proof of Lemma 5.1.
Our second lemma estimates some integrals and ensures that $\Phi$ induces a compact composition operator on $H^{2}\left(\mathbb{D}^{2}\right)$.

Lemma 5.2. For $0<h \leq 1$, the following estimate holds:

$$
\begin{equation*}
I_{0}(h):=\int_{\left|\chi\left(\mathrm{e}^{i t}\right)-1\right| \leq h} \frac{1}{\left(1-\left|\chi\left(\mathrm{e}^{i t}\right)\right|\right)^{2}} d t \lesssim \mathrm{e}^{-\tau / h}, \tag{5.8}
\end{equation*}
$$

Proof. By Proposition 4.1,5), there exist two constants $c_{1}, c_{2}$ such that:

$$
\frac{c_{1}}{\log 1 /|t|} \leq\left|\chi\left(\mathrm{e}^{i t}\right)-1\right| \leq \frac{c_{2}}{\log 1 /|t|}, \quad|t| \leq \pi ;
$$

hence:

$$
I_{0}(h) \lesssim \int_{|t| \leq \mathrm{e}^{-c_{1} / h}}[\log (1 /|t|)]^{2} d t=2 \int_{c_{1} / h}^{\infty} x^{2} \mathrm{e}^{-x} d x \lesssim h^{-2} \mathrm{e}^{-c_{1} / h} .
$$

Corollary 5.3. For $g \in A(\mathbb{D})$ with $0<\|g\|_{\infty} \leq 1$, set:

$$
I(h):=\int_{\left|\chi\left(\mathrm{e}^{i t_{1}}\right)-1\right| \leq h} \frac{d t_{1} d t_{2}}{\left(1-\left|\chi\left(\mathrm{e}^{i t_{1}}\right)\right|\right)\left(1-\left|\chi\left(\mathrm{e}^{t_{1}}\right)+c(\varphi \circ \chi)\left(\mathrm{e}^{i t_{1}}\right) g\left(\mathrm{e}^{i t_{2}}\right)\right|\right)} .
$$

Then:

$$
I(h) \lesssim \mathrm{e}^{-\tau / h} .
$$

Consequently, the composition operator $C_{\Phi}$ defined in (5.4) is bounded from $H^{2}\left(\mathbb{D}^{2}\right)$ to $H^{2}\left(\mathbb{D}^{2}\right)$ and is compact.

Proof. Using (5.6), we have, thanks to (5.8):

$$
I(h) \leq \int_{\left|\chi\left(\mathrm{e}^{i t_{1}}\right)-1\right| \leq h} \frac{2}{\left(1-\left|\chi\left(\mathrm{e}^{i t_{1}}\right)\right|\right)^{2}} d t_{1} d t_{2} \lesssim \mathrm{e}^{-\tau / h} .
$$

In particular, $I(1)<\infty$, showing that $C_{\Phi}$ is Hilbert-Schmidt and hence bounded.

For the rest of the paper, we fix a number $\sigma$ in $(0,1)$, that for convenience we take as:

$$
\begin{equation*}
\sigma=\frac{7}{8}, \tag{5.9}
\end{equation*}
$$

a positive integer $j_{0}$ such that:

$$
\begin{equation*}
2 \sigma^{j_{0}} \leq 1 / 8 \tag{5.10}
\end{equation*}
$$

(i.e. $j_{0} \geq 21$ ), and we set:

$$
\begin{equation*}
a_{j}=1-\sigma^{j} \tag{5.11}
\end{equation*}
$$

and:

$$
\begin{equation*}
\rho_{j}=\frac{\sigma^{j}}{4}=\frac{1}{4}\left(1-a_{j}\right) . \tag{5.12}
\end{equation*}
$$

We also define, for $n \geq 1$ and $\theta$ being the parameter used in (5.1):

$$
\begin{equation*}
N_{n}=\left[\frac{\log 2 n}{\theta \log 1 / \sigma}\right]+1>\frac{\log 2 n}{\log 1 / \sigma} \tag{5.13}
\end{equation*}
$$

The next lemma gives a cutting off for $\chi(\mathbb{D})$.

Lemma 5.4. For every $n \geq 1$, the image $\chi(\mathbb{D})$ of the cusp map, deprived of the closed Euclidean disk $\bar{D}\left(0,1-\sigma^{j_{0}} / K\right)$ and of $\chi(\mathbb{D}) \cap S(1,1 / n)$, can be covered by the open Euclidean disks $D\left(a_{j}, \rho_{j}\right)$, with $j_{0} \leq j \leq N_{n}$.

Proof. Let $z \in \mathbb{D}$ such that $|\chi(z)|>1-\sigma^{j_{0}} / K$ and $|\chi(z)-1|>1 / n$. We write $\chi(z)=x+i y=: 1-h+i y$.

Let $j$ with $a_{j} \leq x<a_{j+1}$, i.e. $\sigma^{j+1}<h \leq \sigma^{j}$. We have $j \geq j_{0}$, since $h<\sigma^{j_{0}}$.

Now, since $0 \leq x-a_{j}<a_{j+1}-a_{j}=\sigma^{j+1}-\sigma^{j}$, that $y^{2} \leq 4 h^{4}$ (Proposition $4.1,6)$ ), and $h \leq \sigma^{j}$, we have:

$$
\left|\chi(z)-a_{j}\right|^{2}<\left(\sigma^{j}-\sigma^{j+1}\right)^{2}+y^{2} \leq(1-\sigma)^{2} \sigma^{2 j}+4 \sigma^{4 j}
$$

hence:

$$
\left|\chi(z)-a_{j}\right|<\sigma^{j}(1-\sigma)+2 \sigma^{2 j}=\sigma^{j}\left(1-\sigma+2 \sigma^{j}\right)
$$

Subsequently, since $1-\sigma=1 / 8, j \geq j_{0}$, and $2 \sigma^{j_{0}} \leq 1 / 8$ :

$$
\left|\chi(z)-a_{j}\right|<\sigma^{j}\left(1-\sigma+2 \sigma^{j_{0}}\right) \leq \frac{\sigma^{j}}{4}=\rho_{j}
$$

showing that $\chi(z) \in D\left(a_{j}, \rho_{j}\right)$.
Moreover, we have $j \leq N_{n}$. Indeed, if $j>N_{n}$, we would have:
$|\chi(z)-1| \leq\left|\chi(z)-a_{j}\right|+\left(1-a_{j}\right) \leq \rho_{j}+\sigma^{j}=\frac{5}{4} \sigma^{j} \leq \frac{5}{4} \sigma^{N_{n}+1} \leq 2 \sigma^{N_{n}} \leq 1 / n$, contradicting the fact that $\chi(z) \notin S(1,1 / n)$.

Our next two lemmas give estimates on derivatives for the functions belonging to $H^{2}\left(\mathbb{D}^{2}\right)$.

Lemma 5.5. Let $f \in H^{2}\left(\mathbb{D}^{2}\right)$, $k$ a non-negative integer, $b \in \mathbb{D}$, and let $h_{k}(z)=\left(D_{2}^{k} f\right)(z, z)$. Then:

$$
\left|h_{k}(b)\right| \leq \frac{k!2^{k+1}}{(1-|b|)^{k+1}}\|f\|_{2}
$$

Proof. The Cauchy inequalities give for $0<s<1-|b|$ and $\alpha \in \mathbb{N}^{2}$ :

$$
\left|D^{\alpha} f(b, b)\right| \leq \frac{\alpha!}{s^{|\alpha|}} \sup _{\left|w_{1}-b\right|=s,\left|w_{2}-b\right|=s}\left|f\left(w_{1}, w_{2}\right)\right|
$$

The choice $s=\frac{1-|b|}{2}$ gives $1-\left|w_{j}\right| \geq \frac{1-|b|}{2}$ for $\left|w_{j}-b\right|=s, j=1,2$; hence, thanks to the estimate (3.2):

$$
\left|f\left(w_{1}, w_{2}\right)\right| \leq \frac{\|f\|_{2}}{\sqrt{\left(1-\left|w_{1}\right|\right)\left(1-\left|w_{2}\right|\right)}} \leq \frac{2}{1-|b|}\|f\|_{2} .
$$

Specializing to $\alpha=(0, k)$ now gives the result.
Lemma 5.6. With the notations of Lemma 5.5, assume that $h_{k}^{(l)}(a)=0$ for some $a \in \mathbb{D}$ and for $0 \leq l<n$. Then, for $0<\rho<1$ and $|b-a| \leq \frac{\rho}{2}(1-|a|)$, it holds:

$$
\left|h_{k}(b)\right| \leq \rho^{n} \frac{k!4^{k+1}}{(1-|a|)^{k+1}}\|f\|_{2} .
$$

Proof. We may assume $\|f\|_{2} \leq 1$. Consider the function defined, for $w \in \mathbb{D}$, by:

$$
H_{k}(w)=h_{k}\left(a+w \frac{1-|a|}{2}\right) .
$$

It is a bounded and holomorphic function in $\mathbb{D}$.
For $w \in \mathbb{D}$, let $\beta=a+w \frac{1-|a|}{2}$, which satisfies $1-|\beta| \geq \frac{1-|a|}{2}$. Lemma 5.5 gives:

$$
\left|H_{k}(w)\right|=\left|h_{k}(\beta)\right| \leq \frac{k!4^{k+1}}{(1-|a|)^{k+1}} .
$$

Now, $H_{k}^{(l)}(0)=h_{k}^{(l)}(a)=0$ for $0 \leq l<n$; hence the Schwarz lemma says that $H_{k}$ satisfies $\left|H_{k}(w)\right| \leq|w|^{n}\left\|H_{k}\right\|_{\infty}$ for all $w \in \mathbb{D}$. Take $w=\frac{2(b-a)}{1-|a|}$, which satisfies $|w| \leq \rho$, to get:

$$
\left|h_{k}(b)\right|=\left|H_{k}(w)\right| \leq|w|^{n}\left\|H_{k}\right\|_{\infty} \leq \rho^{n} \frac{k!4^{k+1}}{(1-|a|)^{k+1}} .
$$

## 6 The main result

Recall that $\chi$ is the cusp map and that $\varphi$ is defined in (5.1). The map $g$ appearing in the formula below plays an inert role, and is just designed to ensure that $\Phi$ is non-degenerate; we can take, for example $g\left(z_{2}\right)=z_{2}$. This seems to mean that non-degeneracy is not the only issue in the question of estimating $\beta_{2}^{+}\left(C_{\Phi}\right)$.

Our example appears as a perturbation of the diagonal map defined by $\Delta\left(z_{1}, z_{2}\right)=\left(\chi\left(z_{1}\right), \chi\left(z_{1}\right)\right)$ for which we already know ([15, Theorem 2.4])
that $\Delta(1,1)=(1,1)$ and $\beta_{2}^{+}\left(C_{\Delta}\right)<1$. This map is degenerate, but the perturbation clearly gives a non degenerate one since its Jacobian is $J_{\Phi}\left(z_{1}, z_{2}\right)=$ $c(\varphi \circ \chi)\left(z_{1}\right) \chi^{\prime}\left(z_{1}\right) g^{\prime}\left(z_{2}\right)$.

Theorem 6.1. Let:

$$
\Phi\left(z_{1}, z_{2}\right)=\left(\chi\left(z_{1}\right), \chi\left(z_{1}\right)+c(\varphi \circ \chi)\left(z_{1}\right) g\left(z_{2}\right)\right)
$$

be the function defined in (5.4).
Then:

1) $\Phi\left(\mathbb{D}^{2}\right) \subseteq \mathbb{D}^{2}$ and $C_{\Phi}: H^{2}\left(\mathbb{D}^{2}\right) \rightarrow H^{2}\left(\mathbb{D}^{2}\right)$ is compact;
2) $\Phi$ is non degenerate, and its components belong to the bidisk algebra;
3) $\Phi\left(\mathbb{T}^{2}\right) \cap \mathbb{T}^{2}=\Phi\left(\mathbb{T}^{2}\right) \cap \partial_{e} \mathbb{D}^{2} \neq \emptyset$;
4) $a_{n^{2}}\left(C_{\Phi}\right) \lesssim \exp (-\tau n)$, for some $\tau>0$, implying $\beta_{2}^{+}\left(C_{\Phi}\right)<1$.

Proof. That $\Phi$ maps $\mathbb{D}^{2}$ to itself is proved in Lemma 5.1 and that the composition operator $C_{\Phi}: H^{2}\left(\mathbb{D}^{2}\right) \rightarrow H^{2}\left(\mathbb{D}^{2}\right)$ is compact, in Corollary 5.3. Item 2) is due to the presence of $g$, as explained above. The fact that $\Phi\left(\mathbb{T}^{2}\right) \cap \mathbb{T}^{2} \neq \emptyset$ is clear since $\Phi(1,1)=(1,1)$. It remains to prove 4$)$.

Once more, the proof will be conveniently divided into several steps. We begin by a lemma which is in fact obvious, but explains well what is going on.
Lemma 6.2. Let $\lambda=1-\frac{\sigma^{j_{0}}}{2 K}$, where $\sigma, K$ and $j_{0}$ are as in (5.9), Proposition 4.1, 2), and (5.10). Let $r_{n}=1-\frac{1}{n}$, and let $\mu_{1}, \mu_{2}, \mu_{3}$ the respective restrictions of $m_{\Phi}$ to the disk $\overline{\lambda \mathbb{D}^{2}}$, the annulus $r_{n} \mathbb{D}^{2} \backslash \overline{\lambda \mathbb{D}^{2}}$, and the annulus $\mathbb{D}^{2} \backslash r_{n} \mathbb{D}^{2}$. We then have:

$$
C_{\Phi}=T_{1} \oplus T_{2} \oplus T_{3}
$$

where $T_{j}$ is the canonical injection of $H^{2}\left(\mathbb{D}^{2}\right)$ into $L^{2}\left(\mu_{j}\right)$.
This is indeed obvious since:

$$
\left\|C_{\Phi} f\right\|^{2}=\int_{\mathbb{D}^{2}}|f|^{2} d m_{\Phi}
$$

and by splitting the integral into three parts.
We now majorize separately the numbers $a_{p}\left(T_{j}\right)$, for $j=1,2,3$. In the sequel, the positive constant $\tau$ may vary from one formula to another.

Step 1. It holds:

$$
\begin{equation*}
a_{n^{2}}\left(T_{1}\right) \lesssim \mathrm{e}^{-\tau n} \tag{6.1}
\end{equation*}
$$

Proof. Let $V=z_{1}^{n} H^{2}\left(\mathbb{D}^{2}\right)+z_{2}^{n} H^{2}\left(\mathbb{D}^{2}\right)$; this is a subspace of $H^{2}\left(\mathbb{D}^{2}\right)$ of codimension $\leq n^{2}$, since:

$$
V=\left\{f \in H^{2}\left(\mathbb{D}^{2}\right) ; D_{1}^{j} D_{2}^{k} f(0,0)=0 \quad \text { for } 0 \leq j, k<n\right\} .
$$

If $f(z)=\sum_{\max (j, k) \geq n} a_{j, k} z_{1}^{j} z_{2}^{k} \in V$ and $\|f\|_{2}=1$, one can write:

$$
f(z)=z_{1}^{n} q_{1}\left(z_{1}, z_{2}\right)+z_{2}^{n} q_{2}\left(z_{1}, z_{2}\right),
$$

with:

$$
q_{1}(z)=\sum_{j \geq n, k \geq 0} a_{j, k} z_{1}^{j-n} z_{2}^{k} \quad \text { and } \quad q_{2}(z)=\sum_{j<n, k \geq n} a_{j, k} z_{1}^{j} z_{2}^{k-n},
$$

which satisfy $\left\|q_{j}\right\|_{2} \leq\|f\|_{2}=1, j=1,2$.
An easy estimate now gives (since $\max \left(\left|z_{1}\right|^{n},\left|z_{2}^{n}\right|\right) \leq \lambda^{n}$ on $\overline{\lambda \mathbb{D}^{2}}$ ):

$$
\begin{aligned}
\left\|T_{1} f\right\|^{2} & \leq 2\left(\int_{\lambda \mathbb{D}^{2}}\left(\left|z_{1}^{n}\right|^{2}\left|q_{1}\left(z_{1}, z_{2}\right)\right|^{2}+\left|z_{2}^{n}\right|^{2}\left|q_{2}\left(z_{1}, z_{2}\right)\right|^{2}\right) d m_{\Phi}\right) \\
& \lesssim \lambda^{2 n} \int_{\lambda \mathbb{D}^{2}}\left(\left|q_{1}\right|^{2}+\left|q_{2}\right|^{2}\right) d m_{\Phi} \lesssim \lambda^{2 n}\left(\left\|q_{1}\right\|_{2}^{2}+\left\|q_{2}\right\|_{2}^{2}\right) \lesssim \lambda^{2 n}
\end{aligned}
$$

since we know by Corollary 5.3 that $C_{\Phi}$ is bounded on $H^{2}\left(\mathbb{D}^{2}\right)$ and hence that $m_{\Phi}$ is a Carleson measure for $H^{2}\left(\mathbb{D}^{2}\right)$. Alternatively, we could majorize $\left|q_{j}\left(z_{1}, z_{2}\right)\right|$ uniformly on the support of $\mu_{1}$. We hence obtain:

$$
\begin{equation*}
a_{n^{2}+1}\left(T_{1}\right)=c_{n^{2}+1}\left(T_{1}\right) \lesssim \mathrm{e}^{-\tau n} . \tag{6.2}
\end{equation*}
$$

Step 2. It holds:

$$
\begin{equation*}
a_{n^{2}}\left(T_{3}\right) \lesssim \mathrm{e}^{-\tau n} \tag{6.3}
\end{equation*}
$$

Proof. In one variable, we could use the Carleson embedding theorem; but this theorem for the bidisk and the Hardy space $H^{2}\left(\mathbb{D}^{2}\right)$ notably has a more complicated statement ([3]; see also [5]), and cannot be used efficiently here. Our strategy will be to replace it by a sharp estimation of a Hilbert-Schmidt norm.

We set $h_{n}=1-r_{n}=1 / n$.
Clearly, denoting by $S_{2}$ the Hilbert-Schmidt class:

$$
\left\|T_{3}\right\|^{2} \leq\left\|T_{3}\right\|_{S_{2}}^{2}=\int \frac{d \mu_{3}(w)}{\left(1-\left|w_{1}\right|^{2}\right)\left(1-\left|w_{2}\right|^{2}\right)} \leq \int \frac{d \mu_{3}(w)}{\left(1-\left|w_{1}\right|\right)\left(1-\left|w_{2}\right|\right)}
$$

Now, if $w=\left(w_{1}, w_{2}\right)=\left(\chi\left(z_{1}\right), \chi\left(z_{1}\right)+c(\varphi \circ \chi)\left(z_{1}\right) g\left(z_{2}\right)\right)$ belongs to the support of $\mu_{3}$, we have $\max \left(\left|w_{1}\right|,\left|w_{2}\right|\right) \geq r_{n}=1-h_{n}$, and, recalling (5.5):

$$
\begin{equation*}
\left|w_{1}\right| \geq 2\left|w_{2}\right|-1 \tag{6.4}
\end{equation*}
$$

we have in either case $\left|w_{1}\right| \geq 1-2 h_{n}$. By Proposition 4.1,2), this implies that:

$$
\left|1-w_{1}\right| \leq 2 K h_{n} .
$$

Corollary 5.3 gives:

$$
\begin{aligned}
\left\|T_{3}\right\|^{2} & \lesssim \int_{\left|\chi\left(\mathrm{e}^{i t_{1}}\right)-1\right| \leq 2 K h_{n}} \frac{d t_{1} d t_{2}}{\left(1-\left|\chi\left(\mathrm{e}^{i t_{1}}\right)\right|\right)\left(1-\left|\chi\left(\mathrm{e}^{i t_{1}}\right)+c(\varphi \circ \chi)\left(\mathrm{e}^{i t_{1}}\right) g\left(\mathrm{e}^{i t_{2}}\right)\right|\right)} \\
& =I\left(2 K h_{n}\right) \lesssim \mathrm{e}^{-\tau / h_{n}} .
\end{aligned}
$$

But $h_{n}=1 / n$, so that:

$$
\begin{equation*}
a_{n^{2}}\left(T_{3}\right) \leq\left\|T_{3}\right\| \lesssim \mathrm{e}^{-\tau n} . \tag{6.5}
\end{equation*}
$$

Step 3. It holds:

$$
\begin{equation*}
a_{n^{2}}\left(T_{2}\right) \lesssim \mathrm{e}^{-\tau n} . \tag{6.6}
\end{equation*}
$$

This estimate follows from the following key auxiliary lemma. In fact, this lemma will give, for the Gelfand numbers, $c_{n^{2}}\left(T_{2}\right) \lesssim \mathrm{e}^{-\tau n}$, and we know that they are equal to the approximation numbers.

Let $M: H^{2}\left(\mathbb{D}^{2}\right) \rightarrow \operatorname{Hol}(\mathbb{D})$ be the linear map defined by:

$$
M f(z)=f(z, z),
$$

Recall that $a_{j}=1-\sigma^{j}$ and $N_{n}=\left[\frac{\log 2 n}{\theta \log 1 / \sigma}\right]+1$.
Lemma 6.3. Let $E$ be the closed subspace of $H^{2}\left(\mathbb{D}^{2}\right)$ defined by:

$$
\begin{aligned}
& E=\left\{f \in H^{2}\left(\mathbb{D}^{2}\right) ;\left[M\left(D_{2}^{k} f\right)\right]^{(l)}\left(a_{j}\right)=0\right. \\
& \text { for } \left.0 \leq l<n, 0 \leq k \leq m_{j}, 1 \leq j \leq N_{n}\right\} .
\end{aligned}
$$

Then, we can adjust the numbers $m_{j}$ so as to guarantee that, for some positive constant $\tau$ :
$\operatorname{codim} E \lesssim n^{2}$
and, for all $f \in E$ with $\|f\|_{2} \leq 1$ :

$$
\left\|T_{2}(f)\right\|_{2} \lesssim \exp (-\tau n)
$$

Proof. This is the most delicate part.
Recall that:

$$
h_{n}=1 / n, \quad r_{n}=1-h_{n}, \quad \lambda=1-\frac{\sigma^{j_{0}}}{2 K} .
$$

We need a uniform estimate of $|f(w)|$ for $f \in E$ with $\|f\|_{2} \leq 1$ and for:

$$
w=\left(w_{1}, w_{2}\right) \in \operatorname{supp} m_{\Phi} \cap\left(r_{n} \mathbb{D}^{2} \backslash \overline{\lambda \mathbb{D}^{2}}\right) .
$$

This estimate will be given by Lemma 5.4, Lemma 5.5 and Lemma 5.6. Note that we have:

$$
\chi\left(z_{1}\right) \in \mathbb{D} \backslash[S(1,1 / n) \cup \bar{D}(0,2 \lambda-1)] .
$$

Indeed, if $\left(w_{1}, w_{2}\right)=\Phi\left(z_{1}, z_{2}\right) \notin \lambda \mathbb{D}^{2}$, we have $\max \left(\left|w_{1}\right|,\left|w_{2}\right|\right)>\lambda$; so either $\left|w_{1}\right|>\lambda \geq 2 \lambda-1$, or $\left|w_{2}\right|>\lambda$ and again $\left|w_{1}\right|>2 \lambda-1$ since $\left|w_{1}\right| \geq 2\left|w_{2}\right|-1$, by (5.5). Hence $w_{1} \notin \bar{D}(0,2 \lambda-1)$. Moreover, we have $\left|1-w_{1}\right| \geq 1-\left|w_{1}\right|>1 / n$, so $w_{1} \notin S(1,1 / n)$.

Using Lemma 5.4 , select $j_{0} \leq j \leq N_{n}$ such that $\left|\chi\left(z_{1}\right)-a_{j}\right| \leq \frac{1}{4}\left(1-a_{j}\right)$. Now set:

$$
A=\left(\chi\left(z_{1}\right), \chi\left(z_{1}\right)\right) \quad \text { and } \quad \Delta=\left(0,(\varphi \circ \chi)\left(z_{1}\right) g\left(z_{2}\right)\right) .
$$

Our strategy will be the following. We write:

$$
\begin{aligned}
f\left[\Phi\left(z_{1}, z_{2}\right)\right]=f(A+\Delta) & =\sum_{k=0}^{\infty} \frac{D_{2}^{k} f(A)}{k!} \Delta^{k} \\
& =\sum_{k=0}^{\infty} \frac{M\left(D_{2}^{k} f\right)\left[\chi\left(z_{1}\right)\right]}{k!} \Delta^{k}=\sum_{k=0}^{\infty} \frac{h_{k}\left[\chi\left(z_{1}\right)\right]}{k!} \Delta^{k},
\end{aligned}
$$

with $h_{k}=M\left(D_{2}^{k} f\right)$, and we put:

$$
S_{j}=\sum_{k=0}^{m_{j}} \frac{h_{k}\left[\chi\left(z_{1}\right)\right]}{k!} \Delta^{k}
$$

and

$$
R_{j}=\sum_{k>m_{j}} \frac{h_{k}\left[\chi\left(z_{1}\right)\right]}{k!} \Delta^{k} .
$$

We will estimate separately $S_{j}$ and $R_{j}$.
a) Estimation of $R_{j}$.

Recall that $j$ is such that $j_{0} \leq j \leq N_{n}$ and $\left|\chi\left(z_{1}\right)-a_{j}\right| \leq \frac{1}{4}\left(1-a_{j}\right)$. We saw in the proof of this Lemma 5.4 that $1-\left|\chi\left(z_{1}\right)\right| \leq \left\lvert\, 1-\chi\left(z_{1}\right) \leq \frac{5}{4} \sigma^{j}\right.$. Hence:

$$
|\Delta| \leq\left|(\varphi \circ \chi)\left(z_{1}\right)\right| \leq \exp \left(-\frac{\delta}{\left|1-\chi\left(z_{1}\right)\right|^{\theta}}\right) \lesssim \exp \left(-\tau \sigma^{-j \theta}\right) .
$$

Now, use Lemma 5.5 and (5.2) to get:

$$
\begin{aligned}
\left|R_{j}\right| & \leq \sum_{k>m_{j}} \frac{2^{k+1}}{\left(1-\left|\chi\left(z_{1}\right)\right|\right)^{k+1}}|\Delta|^{k} \lesssim \sum_{k>m_{j}} 2^{k} \sigma^{-j k} \exp \left(-\tau k \sigma^{-j \theta}\right) \\
& \lesssim 2^{m_{j}} \sigma^{-j m_{j}} \exp \left(-\tau m_{j} \sigma^{-j \theta}\right) \lesssim \exp \left(-\tau m_{j} \sigma^{-j \theta}\right)
\end{aligned}
$$

for some absolute constant $\tau>0$, that is:

$$
\begin{equation*}
\left|R_{j}\right| \lesssim \exp (-\tau n) \tag{6.7}
\end{equation*}
$$

if we take:

$$
\begin{equation*}
m_{j}=\left[n \sigma^{j \theta}\right]+1 \tag{6.8}
\end{equation*}
$$

b) Estimation of $S_{j}$.

We saw in the estimation of $R_{j}$ that $1-\left|\chi\left(z_{1}\right)\right| \gtrsim \sigma^{j}$. Now, remember that $h_{k}^{(l)}\left(a_{j}\right)=0$ for $l<n$, since $f \in E$, we then use Lemma 5.6 to get, when we take the values:

$$
a=a_{j}, \quad 1-a_{j}=\sigma^{j}, \quad b=\chi\left(z_{1}\right), \quad \rho=\frac{1}{2},
$$

a good upper bound for $\frac{h_{k}\left[\chi\left(z_{1}\right)\right]}{k!}$ when $k \leq m_{j}$, namely:

$$
\left|\frac{h_{k}\left[\chi\left(z_{1}\right)\right]}{k!}\right| \lesssim \frac{4^{k+1}}{\sigma^{j(k+1)}} \rho^{n}
$$

We then obtain an estimate of the form:

$$
\begin{aligned}
\left|S_{j}\right| \lesssim \sum_{k=0}^{m_{j}} \rho^{n} \frac{4^{k+1}}{\sigma^{j(k+1)}} & \lesssim \rho^{n} \frac{4^{m_{j}}}{\sigma^{j m_{j}}}=\exp \left(-n \log 2+m_{j} \log 4-j m_{j} \log \frac{7}{8}\right) \\
& \lesssim \exp \left(-4 \tau n+B j m_{j}\right)
\end{aligned}
$$

with $\tau=\frac{1}{4} \log 2$ and $B \leq \log 4+\log (8 / 7) \leq 2$; or else, using (6.8):

$$
\left|S_{j}\right| \lesssim \exp \left(-4 \tau n+B j n \sigma^{j \theta}+B j\right)
$$

But since $\sigma=7 / 8<1$, the implied exponent, for $j_{0} \leq j \leq N_{n}$ :

$$
-4 \tau n+B j n \sigma^{j \theta}+B j=n\left(-4 \tau+B j \sigma^{j \theta}\right)+B j
$$

is $\leq-2 \tau n+B^{\prime} \log n$, provided that we choose $j_{0}$ large enough, namely such that $j_{0}\left(\frac{7}{8}\right)^{j_{0} \theta} \leq 1 / 4$. This implies an inequality of the form:

$$
\begin{equation*}
\left|S_{j}\right| \lesssim \mathrm{e}^{-2 \tau n} n^{B^{\prime}} \lesssim \mathrm{e}^{-\tau n} \tag{6.9}
\end{equation*}
$$

Putting the estimates (6.7) and (6.9) on $R_{j}$ and $S_{j}$ together, we obtain, for every $f \in E$ with $\|f\|_{2} \leq 1$ :

$$
\begin{equation*}
\left\|T_{2} f\right\| \lesssim \mathrm{e}^{-\tau n} \tag{6.10}
\end{equation*}
$$

It remains to bound from above the codimension of $E$. Since $N_{n}=$ $\left[\frac{\log 2 n}{\theta \log 1 / \sigma}\right]+1$ with $\sigma=7 / 8$ and $m_{j}=\left[n \sigma^{j \theta}\right]+1$, we see that:

$$
\operatorname{codim} E \leq \sum_{l=0}^{n-1} \sum_{j=1}^{N_{n}} m_{j} \leq \sum_{l=0}^{n-1} \sum_{j=1}^{N_{n}}\left(n \sigma^{j \theta}+1\right) \lesssim n^{2} \sum_{j=1}^{\infty} \sigma^{j \theta}+n \log n<q n^{2}
$$

Therefore (6.10) can be read as well, remembering the equality of approximation numbers and Gelfand numbers:

$$
\begin{equation*}
a_{q n^{2}}\left(T_{2}\right)=c_{q n^{2}}\left(T_{2}\right) \lesssim \mathrm{e}^{-\tau n} \tag{6.11}
\end{equation*}
$$

Putting the estimates (6.2), (6.5), and (6.11) together ends the proof of Lemma 6.3.

Finally, Lemma 6.2 and (2.5) give:

$$
a_{3 n^{2}}\left(C_{\Phi}\right)=a_{3 n^{2}}\left(T_{1} \oplus T_{2} \oplus T_{3}\right) \leq a_{n^{2}}\left(T_{1}\right)+a_{n^{2}}\left(T_{2}\right)+a_{n^{2}}\left(T_{3}\right) \lesssim \mathrm{e}^{-\tau n}
$$

thereby finishing the proof of Theorem 6.1.
