# Boundedness of composition operators on general weighted Hardy spaces of analytic functions

#### Abstract

We characterize the (essentially) decreasing sequences of positive numbers $\beta=\left(\beta_{n}\right)$ for which all composition operators on $H^{2}(\beta)$ are bounded, where $H^{2}(\beta)$ is the space of analytic functions $f$ in the unit disk such that $\sum_{n=0}^{\infty}\left|c_{n}\right|^{2} \beta_{n}<\infty$ if $f(z)=\sum_{n=0}^{\infty} c_{n} z^{n}$. We also give conditions for the boundedness when $\beta$ is not assumed essentially decreasing.

## 1 Introduction

Let $\beta=\left(\beta_{n}\right)_{n \geq 0}$ be a sequence of positive numbers such that

$$
\begin{equation*}
\liminf _{n \rightarrow \infty} \beta_{n}^{1 / n} \geq 1 \tag{1.1}
\end{equation*}
$$

The associated weighted Hardy space $H^{2}(\beta)$ is the set of analytic functions $f(z)=\sum_{n=0}^{\infty} a_{n} z^{n}$ such that

$$
\begin{equation*}
\|f\|^{2}:=\sum_{n=0}^{\infty}\left|a_{n}\right|^{2} \beta_{n}<\infty . \tag{1.2}
\end{equation*}
$$

In view of (1.1), $H^{2}(\beta)$ is a Hilbert space of analytic functions on $\mathbb{D}$ with the canonical orthonormal basis

$$
\begin{equation*}
e_{n}^{\beta}(z)=\frac{1}{\sqrt{\beta_{n}}} z^{n}, \quad n \geq 0 \tag{1.3}
\end{equation*}
$$

and the reproducing kernel $K_{w}$ given for all $w \in \mathbb{D}$ by

$$
\begin{equation*}
K_{w}(z)=\sum_{n=0}^{\infty} e_{n}^{\beta}(z) \overline{e_{n}^{\beta}(w)}=\sum_{n=0}^{\infty} \frac{1}{\beta_{n}} \bar{w}^{n} z^{n} . \tag{1.4}
\end{equation*}
$$

Indeed, we have:

$$
\left|\sum_{k=0}^{\infty} a_{n} w^{n}\right| \leq\left(\sum_{k=0}^{\infty} \beta_{k}\left|a_{k}\right|^{2}\right)^{1 / 2}\left(\sum_{k=0}^{\infty} \frac{1}{\beta_{k}}|w|^{2 k}\right)^{1 / 2}<\infty
$$

thanks to (1.1).
Note that (1.1) is necessary for $H^{2}(\beta)$ to consist of analytic functions in $\mathbb{D}$. Indeed the fact that $\sum_{n \geq 1} \frac{1}{n \sqrt{\beta_{n}}} z^{n}$ belongs to $H^{2}(\beta)$ and is analytic in $\mathbb{D}$ implies (1.1).

When $\beta_{n} \equiv 1$, we recover the usual Hardy space $H^{2}$.
Note that $H^{2}$ is continuously embedded in $H^{2}(\beta)$ if and only if $\beta$ is bounded above. In particular, this is the case when $\beta$ is non-increasing.

Most of works with weighted Hardy spaces concern the case

$$
\begin{equation*}
\beta_{n}=\int_{0}^{1} t^{n} d \sigma(t) \tag{1.5}
\end{equation*}
$$

where $\sigma$ is a positive measure on $(0,1)$. More specifically the following definition is often used. Let $G:(0,1) \rightarrow \mathbb{R}_{+}$be an integrable function and let $H_{G}^{2}$ be the space of analytic functions $f: \mathbb{D} \rightarrow \mathbb{C}$ such that:

$$
\begin{equation*}
\|f\|_{H_{G}^{2}}^{2}:=\int_{\mathbb{D}}|f(z)|^{2} G\left(1-|z|^{2}\right) d A(z)<\infty \tag{1.6}
\end{equation*}
$$

Such weighted Bergman type spaces are used, for instance, in [11], [10] and in [14]. We have $H_{G}^{2}=H^{2}(\beta)$ with:

$$
\begin{equation*}
\beta_{n}=2 \int_{0}^{1} r^{2 n+1} G\left(1-r^{2}\right) d r=\int_{0}^{1} t^{n} G(1-t) d t \tag{1.7}
\end{equation*}
$$

and the sequence $\beta=\left(\beta_{n}\right)_{n}$ is non-increasing.
Recall that a symbol is a (non constant) analytic self-map $\varphi: \mathbb{D} \rightarrow \mathbb{D}$, and the associated composition operator $C_{\varphi}: H^{2}(\beta) \rightarrow \mathcal{H o l}(\mathbb{D})$ is defined (formally) as:

$$
\begin{equation*}
C_{\varphi}(f)=f \circ \varphi . \tag{1.8}
\end{equation*}
$$

An important question in the theory is to decide when $C_{\varphi}$ is bounded on $H^{2}(\beta)$, i.e. when $C_{\varphi}: H^{2}(\beta) \rightarrow H^{2}(\beta)$.

When $\beta_{n} \equiv 1$, i.e. when $H^{2}(\beta)$ is the usual Hardy space $H^{2}$, it is known ([18, pp. 13-17]) that all symbols generate bounded composition operators. But in Shapiro's presentation, the main point is the case $\varphi(0)=0$ and a subordination principle for subharmonic functions. The case of automorphisms is claimed simple, using an integral representation for the norm and some change of variable. When $\beta$ is defined as in (1.5), one disposes of integral representations for the
norm in $H^{2}(\beta)$, and, as in in the Hardy space case, this integral representation rather easily gives the boundedness of $C_{T_{a}}$ on $H^{2}$, where

$$
\begin{equation*}
T_{a}(z)=\frac{a+z}{1+\bar{a} z} \tag{1.9}
\end{equation*}
$$

for $a \in \mathbb{D}$. But the above representation (1.5) is equivalent, by the Hausdorff moment theorem, to a high regularity of the sequence $\beta$, namely its complete monotony. When integral representations fail, we have to work with bare hands. If the symbol vanishes at the origin, Kacnel'son's theorem (see Theorem 3.6 below) gives a positive answer when $\beta$ is essentially decreasing (see [2] or [13, Theorem 3.12]). Actually that follows from an older theorem of Goluzin [8] (see [5, Theorem 6.3]), which itself uses a refinement by Rogosinski of Littlewood's principle ([5, Theorem 6.2]). So that the main issue remains the boundedness of $C_{T_{a}}$. A polynomial minoration (see Definition 2.3 below) for $\beta$ is necessary for any $C_{T_{a}}$ to be bounded on $H^{2}(\beta)$ (Proposition 2.5) and we showed in [13, end of Section 3] that for $\beta_{n}=\exp (-\sqrt{n}), C_{T_{a}}$ is never bounded on $H^{2}(\beta)$. But this polynomial minoration is not sufficient, as we will see in Theorem 1.1 below, which also evidences the basic role of the maps $T_{a}$ in the question.

So, our goal in this paper is characterizing the sequences $\beta$ for which all composition operators act boundedly on the space $H^{2}(\beta)$, i.e. send $H^{2}(\beta)$ into itself. Eventually, we will obtain in Theorem 3.4 and Theorem 4.1 the following result, where the $\Delta_{2}$-condition is defined in (2.2).

Theorem 1.1. Let $\beta$ be an essentially decreasing sequence of positive numbers. The following assertions are equivalent:

1) all composition operators are bounded on $H^{2}(\beta)$;
2) all maps $T_{a}$, for $0<a<1$, induce bounded composition operators $C_{T_{a}}$ on $H^{2}(\beta)$;
3) for some $a \in(0,1)$, the map $T_{a}$ induces a bounded composition operator $C_{T_{a}}$ on $H^{2}(\beta)$;
4) $\beta$ satisfies the $\Delta_{2}$-condition.

Note that, by definition of the norm of $H^{2}(\beta)$, all rotations $R_{\theta}, \theta \in \mathbb{R}$, induce bounded composition operators on $H^{2}(\beta)$ and send isometrically $H^{2}(\beta)$ into itself.

However, we construct a weight $\beta$ which is not essentially decreasing and for which all composition operators with symbol vanishing at 0 are bounded (Theorem 3.3), though no map $T_{a}$ with $0<a<1$ induces a bounded composition operator (Proposition 4.4).

For spaces of Bergman type $A_{\widetilde{G}}^{2}:=H_{G}^{2}$, where $\widetilde{G}(r)=G\left(1-r^{2}\right)$, defined as the spaces of analytic functions in $\mathbb{D}$ such that $\int_{\mathbb{D}}|f(z)|^{2} \widetilde{G}(|z|) d A<\infty$, for a positive non-increasing continuous function $\widetilde{G}$ on $[0,1)$, Kriete and MacCluer studied in [11] some analogous problems. They proved, in particular [11,

Theorem 3] that, for:

$$
\widetilde{G}(r)=\exp \left(-B \frac{1}{(1-r)^{\alpha}}\right), \quad B>0,0<\alpha \leq 2
$$

and

$$
\varphi(z)=z+t(1-z)^{\beta}, \quad 1<\beta \leq 3,0<t<2^{1-\beta}
$$

then $C_{\varphi}$ is bounded on $A_{\widetilde{G}}^{2}$ if and only if $\beta \geq \alpha+1$.
Here

$$
\beta_{n}=\int_{0}^{1} t^{n} \mathrm{e}^{-B /(1-\sqrt{t})^{\alpha}} d t
$$

and, since $\beta_{n} \approx \exp \left(-c n^{\alpha /(\alpha+1)}\right)$, the sequence $\left(\beta_{n}\right)$ does not satisfy the $\Delta_{2^{-}}$ condition, accordingly to our Theorem 3.4 below.

## 2 Definitions, notation, and preliminary results

The open unit disk of $\mathbb{C}$ is denoted $\mathbb{D}$ and we write $\mathbb{T}$ its boundary $\partial \mathbb{D}$.
We set $e_{n}(z)=z^{n}, n \geq 0$.
As said in the introduction, $H^{2}$ is continuously embedded in $H^{2}(\beta)$ when $\beta$ is non-increasing. In this paper, we need a slightly more general notion.

Definition 2.1. A sequence of positive numbers $\beta=\left(\beta_{n}\right)$ is said essentially decreasing if, for some constant $C \geq 1$, we have, for all $m \geq n \geq 0$ :

$$
\begin{equation*}
\beta_{m} \leq C \beta_{n} \tag{2.1}
\end{equation*}
$$

Note that saying that $\beta$ is essentially decreasing means that the shift operator on $H^{2}(\beta)$ is power bounded.

If $\beta$ is essentially decreasing, and if we set:

$$
\widetilde{\beta}_{n}=\sup _{m \geq n} \beta_{m},
$$

the sequence $\widetilde{\beta}=\left(\widetilde{\beta}_{n}\right)$ is non-increasing and we have $\beta_{n} \leq \widetilde{\beta}_{n} \leq C \beta_{n}$. In particular, the space $H^{2}(\beta)$ is isomorphic to $H^{2}(\widetilde{\beta})$ and $H^{2}(\beta)$ is continuously embedded in $H^{2}$.

Definition 2.2. The sequence of positive numbers $\beta=\left(\beta_{n}\right)$ is said to satisfy the $\Delta_{2}$-condition if there is a positive constant $\delta<1$ such that, for all integers $n \geq 0$ :

$$
\begin{equation*}
\beta_{2 n} \geq \delta \beta_{n} \tag{2.2}
\end{equation*}
$$

Definition 2.3. The sequence of positive numbers $\beta=\left(\beta_{n}\right)$ is said to have a polynomial minoration if there are positive constants $\delta$ and $\alpha$ such that, for all integers $n \geq 1$ :

$$
\begin{equation*}
\beta_{n} \geq \delta n^{-\alpha} \tag{2.3}
\end{equation*}
$$

That means that $H^{2}(\beta)$ is continuously embedded in the weighted Bergman space $\mathfrak{B}_{\alpha}^{2}$ of the analytic functions $f: \mathbb{D} \rightarrow \mathbb{C}$ such that

$$
\|f\|_{\mathfrak{B}_{\alpha}^{2}}^{2}:=(\alpha+1) \int_{\mathbb{D}}|f(z)|^{2}\left(1-|z|^{2}\right)^{\alpha} d A(z)<\infty
$$

since $\mathfrak{B}_{\alpha}^{2}=H^{2}(\gamma)$ with $\gamma_{n} \approx n^{-\alpha}$.
The following simple proposition links those notions.
Proposition 2.4. Let $\beta$ be an essentially decreasing sequence of positive numbers. Then if $\beta$ satisfies the $\Delta_{2}$-condition, it has a polynomial minoration.

The converse does not hold.
Proof. 1) Assume $\beta_{m} \leq C \beta_{n}$ for $m \geq n$ and $\beta_{2 p} \geq \mathrm{e}^{-A} \beta_{p}$. Let now $n$ be an integer $\geq 2$, and $k \geq 1$ the smallest integer such that $2^{k} \geq n$, so that $k \leq a \log n$ with $a$ a positive constant. We get:

$$
\beta_{n} \geq C^{-1} \beta_{2^{k}} \geq C^{-1} \mathrm{e}^{-k A} \beta_{1} \geq C^{-1} \beta_{1} \mathrm{e}^{-a A \log n}=: \rho n^{-\alpha},
$$

with $\rho=C^{-1} \beta_{1}$ and $\alpha=a A$.
2) Let $\delta>0$. We set $\beta_{0}=\beta_{1}=1$ and for $n \geq 2$ :

$$
\beta_{n}=\frac{1}{(k!)^{\delta}} \quad \text { when } k!<n \leq(k+1)!.
$$

The sequence $\beta$ is non-increasing.
For $n$ and $k$ as above, we have:

$$
\beta_{n}=\frac{1}{(k!)^{\delta}} \geq \frac{1}{n^{\delta}}
$$

hence $\beta$ has arbitrary polynomial minoration. However we have, for $k \geq 2$ :

$$
\frac{\beta_{2 k!}}{\beta_{k!}}=\frac{(k!)^{-\delta}}{[(k-1)!]^{-\delta}}=\frac{1}{k^{\delta}} \underset{k \rightarrow \infty}{\longrightarrow} 0
$$

so $\beta$ fails to satisfy the $\Delta_{2}$-condition.
For $a \in \mathbb{D}$, we define:

$$
\begin{equation*}
T_{a}(z)=\frac{a+z}{1+\bar{a} z}, \quad z \in \mathbb{D} \tag{2.4}
\end{equation*}
$$

Recall that $T_{a}$ is an automorphism of $\mathbb{D}$ and that $T_{a}(0)=a$ and $T_{a}(-a)=0$.
Though we do not need this, we may remark that $\left(T_{a}\right)_{a \in(-1,1)}$ is a group and $\left(T_{a}\right)_{a \in(0,1)}$ is a semigroup. It suffices to see that $T_{a} \circ T_{b}=T_{a * b}$, with:

$$
\begin{equation*}
a * b=\frac{a+b}{1+a b} \tag{2.5}
\end{equation*}
$$

Proposition 2.5. Let $a \in(0,1)$ and assume that $T_{a}$ induces a bounded composition operator on $H^{2}(\beta)$. Then $\beta$ has a polynomial minoration.
Remarks. 1) For example, when $\beta_{n}=\exp \left[-c(\log (n+1))^{2}\right]$, with $c>0$, no $T_{a}$ induces a bounded composition operator on $H^{2}(\beta)$, though all symbols $\varphi$ with $\varphi(0)=0$ are bounded, since $\beta$ is decreasing, as said by the forthcoming Proposition 3.2.
2) For the Dirichlet space $\mathcal{D}^{2}$, we have $\beta_{n}=n+1$, but all the maps $T_{a}$ induce bounded composition operators on $\mathcal{D}^{2}$ (see [13, Remark before Theorem 3.12]). In this case $\beta$ has a polynomial minoration though it is not bounded above.
3) However, even for decreasing sequences, a polynomial minoration for $\beta$ is not enough for some $T_{a}$ to induce a bounded composition operator. Indeed, we saw in Proposition 2.4 an example of a decreasing sequence $\beta$ with polynomial minoration, but not sharing the $\Delta_{2}$-condition, and we will see in Theorem 4.1 that the $\Delta_{2}$-condition is needed for having some $T_{a}$ inducing a bounded composition operator.
4) In [7], Eva Gallardo-Gutiérrez and Jonathan Partington give estimates for the norm of $C_{T_{a}}$, with $a \in(0,1)$, when $C_{T_{a}}$ is bounded on $H^{2}(\beta)$. More precisely, they proved that if $\beta$ is bounded above and $C_{T_{a}}$ is bounded, then

$$
\left\|C_{T_{a}}\right\| \geq\left(\frac{1+a}{1-a}\right)^{\sigma}
$$

where $\sigma=\inf \left\{s \geq 0 ;(1-z)^{-s} \notin H^{2}(\beta)\right\}$, and

$$
\left\|C_{T_{a}}\right\| \leq\left(\frac{1+a}{1-a}\right)^{\tau}
$$

where $\tau=\frac{1}{2} \sup$ Re $W(A)$, with $A$ the infinitesimal generator of the continuous semigroup $\left(S_{t}\right)$ defined as $S_{t}=C_{T_{\tanh t}}$, namely $(A f)(z)=f^{\prime}(z)\left(1-z^{2}\right)$, and $W(A)$ its numerical range.

For $\beta_{n}=1 /(n+1)^{\nu}$ with $0 \leq \nu \leq 1$, the two bounds coincide, so they get $\left\|C_{T_{a}}\right\|=\left(\frac{1+a}{1-a}\right)^{(\nu+1) / 2}$.

Proof of Proposition 2.5. Since

$$
\left\|K_{x}\right\|^{2}=\sum_{n=0}^{\infty} \frac{x^{2 n}}{\beta_{n}}
$$

we have $\left\|K_{x}\right\| \leq\left\|K_{y}\right\|$ for $0 \leq x \leq y<1$.
We define by induction a sequence $\left(u_{n}\right)_{n \geq 0}$ with:

$$
u_{0}=0 \quad \text { and } \quad u_{n+1}=T_{a}\left(u_{n}\right)
$$

Since $T_{a}(1)=1$ (recall that $a \in(0,1)$ ), we have:

$$
1-u_{n+1}=\int_{u_{n}}^{1} T_{a}^{\prime}(t) d t=\int_{u_{n}}^{1} \frac{1-a^{2}}{(1+a t)^{2}} d t
$$

hence

$$
\frac{1-a}{1+a}\left(1-u_{n}\right) \leq 1-u_{n+1} \leq\left(1-a^{2}\right)\left(1-u_{n}\right)
$$

Let $0<x<1$. We can find $N \geq 0$ such that $u_{N} \leq x<u_{N+1}$. Then:

$$
1-x \leq 1-u_{N} \leq\left(1-a^{2}\right)^{N}
$$

On the other hand, since $C_{T_{a}}^{*} K_{z}=K_{T_{a}(z)}$ for all $z \in \mathbb{D}$, we have:

$$
\left\|K_{x}\right\| \leq\left\|K_{u_{N+1}}\right\| \leq\left\|C_{T_{a}}\right\|\left\|K_{u_{N}}\right\| \leq\left\|C_{T_{a}}\right\|^{N+1}\left\|K_{u_{0}}\right\|=\left\|C_{T_{a}}\right\|^{N+1}
$$

Let $s \geq 0$ such that $\left(1-a^{2}\right)^{-s}=\left\|C_{T_{a}}\right\|$. We obtain:

$$
\begin{equation*}
\left\|K_{x}\right\| \leq\left\|C_{T_{a}}\right\| \frac{1}{(1-x)^{s}} \tag{2.6}
\end{equation*}
$$

But

$$
\left\|K_{x}\right\|^{2}=\sum_{k=0}^{\infty} \frac{x^{2 k}}{\beta_{k}}
$$

so we get, for any $k \geq 2$ :

$$
\frac{x^{2 k}}{\beta_{k}} \leq\left\|C_{T_{a}}\right\|^{2} \frac{1}{(1-x)^{2 s}}
$$

Taking $x=1-\frac{1}{k}$, we obtain $\beta_{k} \geq C k^{-2 s}$.
Remark. We saw in the proof of Proposition 2.5 that if $C_{T_{a}}$ is bounded on $H^{2}(\beta)$ for some $a \in(0,1)$, then the reproducing kernels $K_{w}$ have, by (2.6), a slow growth:

$$
\begin{equation*}
\left\|K_{w}\right\| \leq \frac{C}{(1-|w|)^{s}} \tag{2.7}
\end{equation*}
$$

for positive constants $C$ and $s$. Actually, we have the following equivalence.
Proposition 2.6. The sequence $\beta$ has a polynomial minoration if and only if the reproducing kernels $K_{w}$ of $H^{2}(\beta)$ have a slow growth.

Proof. The sufficiency is easy and seen at the end of the proof of Proposition 2.5. For the necessity, we only have to see that:

$$
\left\|K_{w}\right\|^{2}=\frac{1}{\beta_{0}}+\sum_{n=1}^{\infty} \frac{|w|^{2 n}}{\beta_{n}} \leq \frac{1}{\beta_{0}}+\delta^{-1} \sum_{n=1}^{\infty} n^{\alpha}|w|^{2 n} \leq \frac{C}{\left(1-|w|^{2}\right)^{\alpha+1}}
$$

## 3 Boundedness of composition operators

We study in this section conditions ensuring that all composition operators on $H^{2}(\beta)$ are bounded.

### 3.1 Conditions on the weight

We begin with this simple observation.
Proposition 3.1. If all composition operators, and even if all composition operators with symbol vanishing at 0 , are bounded on $H^{2}(\beta)$, then the sequence $\beta$ is bounded above.

Proof. If $\beta$ is not bounded above, there is a subsequence $\left(\beta_{n_{k}}\right)$, with $n_{k} \geq 1$, such that $\beta_{n_{k}} \geq 4^{k}$. Then $\varphi(z)=\sum_{k=1}^{\infty} 2^{-k} z^{n_{k}}$ defines a symbol, since $|\varphi(z)|<1$, and $\varphi(0)=0$; but:

$$
\left\|C_{\varphi}\left(e_{1}\right)\right\|^{2}=\|\varphi\|^{2}=\sum_{k=1}^{\infty} 4^{-k} \beta_{n_{k}}=\infty .
$$

For symbols vanishing at 0 , we have the following characterization.
Proposition 3.2. The following assertions are equivalent:

1) all symbols $\varphi$ such that $\varphi(0)=0$ induce bounded composition operators $C_{\varphi}$ on $H^{2}(\beta)$ and

$$
\begin{equation*}
\sup _{\varphi(0)=0}\left\|C_{\varphi}\right\|<\infty ; \tag{3.1}
\end{equation*}
$$

2) $\beta$ is an essentially decreasing sequence.

Of course, by the uniform boundedness principle, (3.1) is equivalent to:

$$
\sup _{\varphi(0)=0}\|f \circ \varphi\|<\infty \quad \text { for all } f \in H^{2}(\beta) .
$$

Proof. 2) $\Rightarrow 1$ ) We may assume that $\beta$ is non-increasing. Then the GoluzinRogosinski theorem ([5, Theorem 6.3]) gives the result; in fact, writing $f(z)=$ $\sum_{n=0}^{\infty} c_{n} z^{n}$ and $\left(C_{\varphi} f\right)(z)=\sum_{n=0}^{\infty} d_{n} z^{n}$, it says that:

$$
\left\|C_{\varphi} f\right\|^{2}=\left|d_{0}\right|^{2} \beta_{0}+\sum_{n=1}^{\infty}\left|d_{n}\right|^{2} \beta_{n} \leq\left|c_{0}\right|^{2} \beta_{0}+\sum_{n=1}^{\infty}\left|c_{n}\right|^{2} \beta_{n}=\|f\|^{2}
$$

leading to $C_{\varphi}$ bounded and $\left\|C_{\varphi}\right\| \leq 1$. Alternatively, we can use a result of Kacnel'son ([9]; see also [2], [3, Corollary 2.2], or [13, Theorem 3.12]). This result was also proved by C. Cowen [4, Corollary of Theorem 7].

1) $\Rightarrow 2)$ Set $M=\sup _{\varphi(0)=0}\left\|C_{\varphi}\right\|$. Let $m>n$, and take:

$$
\varphi(z)=z\left(\frac{1+z^{m-n}}{2}\right)^{1 / n}
$$

Then $\varphi(0)=0$ and $[\varphi(z)]^{n}=\frac{z^{n}+z^{m}}{2}$; hence

$$
\frac{1}{4}\left(\beta_{n}+\beta_{m}\right)=\left\|\varphi^{n}\right\|^{2}=\left\|C_{\varphi}\left(e_{n}\right)\right\|^{2} \leq\left\|C_{\varphi}\right\|^{2}\left\|e_{n}\right\|^{2} \leq M^{2} \beta_{n}
$$

so $\beta$ is essentially decreasing.
For example, let $\left(\beta_{n}\right)$ such that $\beta_{2 k+2} / \beta_{2 k+1} \underset{k \rightarrow \infty}{\longrightarrow} \infty$ (for instance $\beta_{2 k}=1$ and $\beta_{2 k+1}=1 /(k+1)$; if $\varphi(z)=z^{2}$, then $\left\|C_{\varphi}\left(z^{2 n+1}\right)\right\|^{2}=\left\|z^{2(2 n+1)}\right\|^{2}=$ $\beta_{2(2 n+1)}$; since $\left\|z^{2 n+1}\right\|^{2}=\beta_{2 n+1}, C_{\varphi}$ is not bounded on $H^{2}(\beta)$.

A more interesting example is the following. For $0<r<1$, let $\beta_{n}=\pi n r^{2 n}$. This sequence is eventually decreasing, so it is essentially decreasing. The square of the norm $\|f\|_{H^{2}(\beta)}^{2}$ is the area of the part of the Riemann surface on which $r \mathbb{D}$ is mapped by $f$. E. Reich [17], generalizing Goluzin's result [8] (see [5, Theorem 6.3]), proved that for all symbols $\varphi$ such that $\varphi(0)=0$, the composition operator $C_{\varphi}$ is bounded on $H^{2}(\beta)$ and

$$
\left\|C_{\varphi}\right\| \leq \sup _{n \geq 1} \sqrt{n} r^{n-1} \leq \frac{1}{\sqrt{2 \mathrm{e}}} \frac{1}{r \sqrt{\log (1 / r)}}
$$

For $0<r<1 / \sqrt{2}$, Goluzin's theorem asserts that $\left\|C_{\varphi}\right\| \leq 1$.
Note that this sequence $\beta$ does not satisfy the $\Delta_{2}$-condition since $\beta_{2 n} / \beta_{n}=$ $2 r^{2 n}$, Theorem 4.1 below states that no composition operator $C_{T_{a}}$ is bounded.

However that the weight $\beta$ is essentially decreasing is not necessary for the boundedness of all composition operators $C_{\varphi}$, with $\operatorname{symbol} \varphi$ vanishing at 0 . as stated by the following theorem, whose proof will be given in Section 3.3.

Theorem 3.3. There exists a bounded sequence $\beta$, with a polynomial minoration, but which is not essentially decreasing, for which every composition operator with symbol vanishing at 0 is bounded on $H^{2}(\beta)$.

It should be noted that for this weight, the composition operators are not all bounded, as we will see in Proposition 4.4.

### 3.2 Boundedness of composition operators I

We now have one of the the main results of this section.
Theorem 3.4. Let $H^{2}(\beta)$ be a weighted Hardy space with $\beta=\left(\beta_{n}\right)$ essentially decreasing and satisfying the $\Delta_{2}$-condition. Then all composition operators on $H^{2}(\beta)$ are bounded.

For the proof, we need a lemma.

Lemma 3.5. For $0<a<1$, we write:

$$
\begin{equation*}
\left(T_{a} z\right)^{n}=\sum_{m=0}^{\infty} a_{m, n} z^{m} \tag{3.2}
\end{equation*}
$$

Then, for every $\alpha>0$, there exists a positive constant $\rho$, depending on $a$, such that:

$$
\begin{equation*}
\left|a_{m, n}\right| \leq \mathrm{e}^{-\alpha(\rho n-m)} \tag{3.3}
\end{equation*}
$$

Note that this estimate is interesting only when $m<\rho n$ since we know that $\left|a_{m, n}\right| \leq\left\|T_{a}{ }^{n}\right\|_{\infty}=1$ for all $m$ and $n$.

Proof. For $0<r<1$, let:

$$
M(r)=\sup _{|z|=r}\left|T_{a}(z)\right|=\sup _{|z|=r}\left|\frac{z+a}{1+a z}\right| .
$$

We have $M(r)<1$, so we can write $M(r)=r^{\rho}$, for some positive $\rho=\rho(a)$.
The Cauchy inequalities give:

$$
\left|a_{m, n}\right| \leq \frac{[M(r)]^{n}}{r^{m}}=r^{\rho n-m}
$$

and we obtain the result by taking $r=\mathrm{e}^{-\alpha}$.
Proof of Theorem 3.4. We may, and do, assume that $\beta$ is non-increasing.
Proposition 3.2 gives the result when $\varphi(0)=0$.
It remains to show that all $C_{T_{a}}, a \in \mathbb{D}$, are bounded. Indeed, if $a=\varphi(0)$ and $\psi=T_{-a} \circ \varphi$, then $\psi(0)=0$ and $\varphi=T_{a} \circ \psi$, so $C_{\varphi}=C_{\psi} \circ C_{T_{a}}$. Moreover, we have only to show that when $a \in[0,1)$. Indeed, if $a \in \mathbb{D}$ and $a=|a| \mathrm{e}^{i \theta}$, we have $T_{a}=R_{\theta} \circ T_{|a|} \circ R_{-\theta}$, so $C_{T_{a}}=C_{R_{-\theta}} \circ C_{T_{|a|}} \circ C_{R_{\theta}}$.

We consider the matrices

$$
A=\left(a_{m, n}\right)_{m, n \geq 0} \quad \text { and } \quad A_{\beta}=\left(\sqrt{\frac{\beta_{m}}{\beta_{n}}} a_{m, n}\right)_{m, n \geq 0}
$$

Since $C_{T_{a}} e_{n}=T_{a}{ }^{n}$, the formula (3.2) shows that $A$ is the matrix of $C_{T_{a}}$ in $H^{2}$ with respect to the basis $\left(e_{n}\right)_{n \geq 0}$. On the other hand, $A_{\beta}$ is the matrix of $C_{T_{a}}$ in $H^{2}(\beta)$ with respect to the basis $\left(e_{n}^{\beta}\right)_{n \geq 0}$. We note that $A_{\beta}=B A B^{-1}$, where $B$ is the diagonal matrix with values $\sqrt{\beta_{0}}, \sqrt{\beta_{1}}, \ldots$ on the diagonal.

Since $C_{T_{a}}$ is a bounded composition operators on $H^{2}$, the matrix $A$ defines a bounded operator on $\ell_{2}$. We have to show that $A_{\beta}$ also, i.e. $\left\|A_{\beta}\right\|<\infty$.

For that purpose, we split $A$ and $A_{\beta}$ into several sub-matrices.
Let $N$ be an integer such that $N \geq 2 / \rho$, where $\rho$ is defined in Lemma 3.5 (actually, the proof of that lemma shows that we can take $\rho$ such that $1 / \rho$ is
an integer, so we could take $N=2 / \rho)$. Let $I_{0}=\left[0, N\left[J_{0}=[N,+\infty[\right.\right.$ and for $k=1,2, \ldots$ :

$$
I_{k}=\left[N^{k}, N^{k+1}\left[\quad \text { and } \quad J_{k}=\left[N^{k+1},+\infty[.\right.\right.\right.
$$

We define the matrices $D_{\beta}$ and $R_{\beta}$, whose entries are respectively:

$$
d_{m, n}=\left\{\begin{array}{lll}
\sqrt{\frac{\beta_{m}}{\beta_{n}}} a_{m, n} & \text { if } \\
0 & \text { elsewhere } ; & (m, n) \in \bigcup_{k=0}^{\infty}\left(I_{k} \times I_{k}\right)
\end{array}\right.
$$

and

$$
r_{m, n}=\left\{\begin{array}{lll}
\sqrt{\frac{\beta_{m}}{\beta_{n}}} a_{m, n} & \text { if } \\
0 & \text { elsewhere. }
\end{array} \quad(m, n) \in \bigcup_{k=0}^{\infty}\left(I_{k} \times I_{k+1}\right)\right.
$$

We also define the matrix $S_{\beta}$ with entries:

$$
s_{m, n}=\left\{\begin{array}{ll}
\sqrt{\frac{\beta_{m}}{\beta_{n}}} a_{m, n} & \text { if } \\
0 & \text { elsewhere. }
\end{array} \quad(m, n) \in \bigcup_{k=0}^{\infty}\left(J_{k} \times I_{k}\right)\right.
$$

Matrices $D, R$, and $S$ are constructed in the same way from $A$ and we set $U=A-(D+R+S)$.

Now, let $H_{k}$ be the subspace of the sequences $\left(x_{n}\right)_{n \geq 0}$ in $\ell_{2}$ such that $x_{n}=0$ for $n \notin I_{k}$, i.e. $H_{k}=\operatorname{span}\left\{e_{k} ; k \in I_{k}\right\}$, and let $P_{k}^{-}$be (the matrix of) the orthogonal projection of $\ell_{2}$ with range $H_{k}$. We have:

$$
D=\sum_{k=0}^{\infty} P_{k} A P_{k} \quad \text { and } \quad R=\sum_{k=0}^{\infty} P_{k} A P_{k+1}
$$

where $D_{k}=P_{k} A P_{k}$ is the matrix with entries $a_{m, n}$ when $(m, n) \in I_{k} \times I_{k}$ and 0 elsewhere, and $R_{k}=P_{k} A P_{k+1}$ the matrix with entries $a_{m, n}$ when $(m, n) \in$ $I_{k} \times I_{k+1}$ and 0 elsewhere.
$\left(\begin{array}{c|c|c|cc}\hline D_{0} & R_{0} & & & \\ \hline S_{0} & S_{1} & R_{1} & & \\\right.$\cline { 2 - 4 } \& \& $\left.D_{2} & R_{2} \\ & & & \end{array}\right)$

Since the subspaces $H_{k}$ are orthogonal, the matrices $D$ and $R$ induce bounded operators on $\ell_{2}$, and

$$
\begin{equation*}
\|D\| \leq\|A\|, \quad\|R\| \leq\|A\| . \tag{3.4}
\end{equation*}
$$

Now, for $k \geq 1$, let $B_{k}$ be the diagonal matrix whose entries are $b_{m, m}=\sqrt{\beta_{m}}$ if $m \in I_{k}$ and $b_{m, n}=0$ otherwise.

Then $P_{k} D_{\beta} P_{k}=P_{k} B_{k} D B_{k}^{-1} P_{k}$, so

$$
\left\|P_{k} D_{\beta} E_{k}\right\| \leq\left\|B_{k}\right\|\left\|B_{k}^{-1}\right\|\|D\| \leq \max _{j \in I_{k}} \sqrt{\beta_{j}} \max _{j \in I_{k}} \frac{1}{\sqrt{\beta_{j}}}\|A\|
$$

But the weight $\beta$ satisfies the $\Delta_{2}$-condition: $\beta_{2 l} \geq \delta_{0} \beta_{l}$, and it follows that for every $l \geq 1$ :

$$
\beta_{N l} \geq \delta^{2} \beta_{l}
$$

for some other constant $\delta$, chosen small enough to have $\left\|P_{0} D_{\beta} P_{0}\right\| \leq \delta^{-1}\|A\|$. Since $\beta$ is non-increasing, we have $\beta_{j} \geq \delta^{2} \beta_{N^{k}}$ for $N^{k} \leq j \leq N^{k+1}$. In particular $\max _{j \in I_{k}} \sqrt{\beta_{j}} \leq \delta^{-1} \min _{j \in I_{k}} \sqrt{\beta_{j}}$ and

$$
\left\|P_{k} D_{\beta} P_{k}\right\| \leq \delta^{-1}\|A\|
$$

Hence, by orthogonality of the subspaces $H_{k}$ :

$$
\begin{equation*}
\left\|D_{\beta}\right\| \leq \delta^{-1}\|D\| \tag{3.5}
\end{equation*}
$$

In the same way, we have $P_{k} R_{\beta} P_{k}=P_{k} B_{k} D B_{k+1}^{-1} P_{k}$, so:

$$
\left\|P_{k} R_{\beta} P_{k}\right\| \leq \max _{j \in I_{k}} \sqrt{\beta_{j}} \max _{j \in I_{k+1}} \frac{1}{\sqrt{\beta_{j}}}\|A\|
$$

and, since $n \leq N^{k+2} \leq N^{2} m$ when $(m, n) \in I_{k} \times I_{k+1}$, we get $\max _{j \in I_{k}} \sqrt{\beta_{j}} \leq$ $\delta^{-2} \min _{j \in I_{k+1}} \sqrt{\beta_{j}}$, so

$$
\begin{equation*}
\left\|R_{\beta}\right\| \leq \delta^{-2}\|R\| \tag{3.6}
\end{equation*}
$$

Next, consider $U=A-(D+R+S)$; we can compute its Hilbert-Schmidt norm using Lemma 3.5. Note that $u_{m, n} \neq 0$ only (if it happens) when $m \in I_{k}$ for some $k \geq 0$ and $n \geq \max I_{k+1}>N^{k+2}>N m$, since $m \in I_{k}$, so only when $m<\rho n / 2$. We have, since then $u_{m, n}=a_{m, n}$ :

$$
\|U\|_{H S}^{2} \leq \sum_{n=0}^{\infty} \sum_{m<\rho n / 2}\left|a_{m, n}\right|^{2} \leq \sum_{n=0}^{\infty} \sum_{m<\rho n / 2} \mathrm{e}^{-2 \alpha(\rho n-m)} \leq \sum_{n=0}^{\infty} \frac{\rho n}{2} \mathrm{e}^{-\alpha \rho n}<\infty
$$

Consequently, with (3.4), we have $\|S\| \leq\|A\|+\|D\|+\|R\|+\|U\|<\infty$.
Now, since $S$ is a lower-triangular matrix and $\beta$ is non-increasing, we can use the following result of V. È Kacnel'son ([9]; see also [2], [3, Corollary 2.2], or [13, Theorem 3.12]), with $\gamma_{j}=1 / \sqrt{\beta_{j}}$.

Theorem 3.6 (V. E Kacnel'son). Let $H$ be a separable complex Hilbert space and $\left(e_{i}\right)_{i \geq 0}$ a fixed orthonormal basis of $H$. Let $M: H \rightarrow H$ be a bounded linear operator. We assume that the matrix of $M$ with respect to this basis is lower-triangular: $\left\langle M e_{j} \mid e_{i}\right\rangle=0$ for $i<j$.

Let $\left(\gamma_{j}\right)_{j \geq 0}$ be a non-decreasing sequence of positive real numbers and $\Gamma$ the (possibly unbounded) diagonal operator such that $\Gamma\left(e_{j}\right)=\gamma_{j} e_{j}, j \geq 0$. Then the operator $\Gamma^{-1} M \Gamma: H \rightarrow H$ is bounded and moreover:

$$
\left\|\Gamma^{-1} M \Gamma\right\| \leq\|M\|
$$

We get that $S_{\beta}$ defines a bounded operator and $\left\|S_{\beta}\right\| \leq\|S\|$.
Further, Proposition 2.4 says that $\beta$ has a polynomial minoration:

$$
\beta_{n} \geq c n^{-\sigma}
$$

for positive constants $c$ and $\sigma$. Then, if $U_{\beta}=A_{\beta}-\left(D_{\beta}+R_{\beta}+S_{\beta}\right)$, we have:

$$
\left\|U_{\beta}\right\|_{H S}^{2} \leq \sum_{n=0}^{\infty} \sum_{m<\rho n / 2} \frac{\left|a_{m, n}\right|^{2}}{\beta_{n}} \leq \sum_{n=0}^{\infty} \frac{\rho n}{2} \mathrm{e}^{-\alpha \rho n} \frac{n^{\sigma}}{c}<\infty
$$

Putting this together with (3.5) and (3.6), we finally obtain that $A_{\beta}=$ $S_{\beta}+D_{\beta}+R_{\beta}+U_{\beta}$ is the matrix of a bounded operator, and that ends the proof of Theorem 3.4.

### 3.3 Boundedness of composition operators II

In this section, we give a sufficient condition for the boundedness of composition operators with symbol vanishing at 0 .

Theorem 3.7. Let $\beta=\left(\beta_{n}\right)_{n=0}^{\infty}$ be a bounded sequence of positive numbers with a polynomial minoration. Assume that:

$$
\begin{align*}
& \text { For every } \delta>0 \text {, there exists } C=C(\delta) \text { such that } \\
& \qquad \beta_{m} \leq C \beta_{n} \quad \text { whenever } m>(1+\delta) n \tag{3.7}
\end{align*}
$$

Then, for all symbols $\varphi: \mathbb{D} \rightarrow \mathbb{D}$ vanishing at 0 , the composition operator $C_{\varphi}$ is bounded on $H^{2}(\beta)$.

To prove Theorem 3.7, we need several lemmas.
Lemma 3.8. Let $\varphi: \mathbb{D} \rightarrow \mathbb{D}$ be an analytic self-map such that $\varphi(0)=0$ and $\left|\varphi^{\prime}(0)\right|<1$. Then there exists $\rho>0$ such that

$$
\left|\widehat{\varphi^{n}}(m)\right| \leq \exp \left(-\frac{1}{2}[(1+\rho) n-m]\right)
$$

Proof. It is the same as that of Lemma 3.5. Since $\varphi(0)=0$, we can write $\varphi(z)=$ $z \varphi_{1}(z)$. Since $\left|\varphi^{\prime}(0)\right|<1$, we have $\varphi_{1}: \mathbb{D} \rightarrow \mathbb{D}$. Let $M(r)=\sup _{|z|=r}\left|\varphi_{1}(z)\right|$. The Cauchy inequalities say that $\left|\widehat{\varphi_{1}^{n}}(m)\right| \leq[M(r)]^{n} / r^{m}$. We have $M(r)<1$, so there exists a positive number $\rho=\rho(r)$ such that $M(r)=r^{\rho}$. We get:

$$
\left|\widehat{\varphi^{n}}(m)\right|=\left|\widehat{\varphi_{1}^{n}}(m-n)\right| \leq \frac{r^{\rho}}{r^{m-n}}=r^{(1+\rho) n-m}
$$

and the result follows, by taking $r=\mathrm{e}^{-1 / 2}$.
The next lemma is a variant of Theorem 3.6, with the same proof.
Lemma 3.9. Let $A: \ell_{2} \rightarrow \ell_{2}$ be a bounded operator represented by the matrix $\left(a_{m, n}\right)_{m, n}$, i.e. $a_{m, n}=\left\langle A e_{n}, e_{m}\right\rangle$.

Let $\left(d_{n}\right)$ be a sequence of positive numbers such that, for every $m$ and $n$ :

$$
\begin{equation*}
d_{m}<d_{n} \quad \Longrightarrow \quad a_{m, n}=0 \tag{3.8}
\end{equation*}
$$

Then, $D$ being the diagonal operator with entries $d_{n}$, we have:

$$
\left\|D^{-1} A D\right\| \leq\|A\|
$$

For convenience of the reader, we reproduce the proof.
Proof. Let $\mathbb{C}_{0}$ be the right-half plane $\mathbb{C}_{0}=\{z \in \mathbb{C} ; \mathfrak{R e} z>0\}$. We set $H_{N}=$ $\operatorname{span}\left\{e_{n} ; n \leq N\right\}$ and

$$
A_{N}=P_{N} A J_{N}
$$

where $P_{N}$ is the orthogonal projection from $H$ onto $H_{N}$ and $J_{N}$ the canonical injection from $H_{N}$ into $H$. We consider, for $z \in \overline{\mathbb{C}_{0}}$ :

$$
A_{N}(z)=D^{-z} A_{N} D^{z}: H_{N} \rightarrow H_{N},
$$

where $D^{z}\left(e_{n}\right)=d_{n}^{z} e_{n}$.
If $\left(a_{m, n}(z)\right)_{m, n}$ is the matrix of $A_{N}(z)$ on the basis $\left\{e_{n} ; n \leq N\right\}$ of $H_{N}$, we clearly have:

$$
a_{m, n}(z)=a_{m, n}\left(d_{n} / d_{m}\right)^{z} .
$$

In particular, we have, thanks to (3.8):

$$
a_{m, n}(z)=0 \quad \text { if } d_{m}<d_{n}
$$

and

$$
\left|a_{m, n}(z)\right| \leq \sup _{k, l}\left|a_{k, l}\right|:=M, \quad \text { for all } z \in \overline{\mathbb{C}_{0}}
$$

Since $\left\|A_{N}(z)\right\|^{2} \leq\left\|A_{N}(z)\right\|_{H S}^{2}=\sum_{m, n \leq N}\left|a_{m, n}^{N}(z)\right|^{2} \leq(N+1)^{2} M^{2}$, we get:

$$
\left\|A_{N}(z)\right\| \leq(N+1) M \quad \text { for all } z \in \overline{\mathbb{C}_{0}}
$$

Let us consider the function $u: \overline{\mathbb{C}_{0}} \rightarrow \overline{\mathbb{C}_{0}}$ defined by:

$$
\begin{equation*}
u_{N}(z)=\left\|A_{N}(z)\right\| \tag{3.9}
\end{equation*}
$$

This function $u_{N}$ is continuous on $\overline{\mathbb{C}_{0}}$, bounded above by $(N+1) M$, and subharmonic in $\mathbb{C}_{0}$. Moreover, thanks to (3.8), the maximum principle gives:

$$
\sup _{\overline{\mathbb{C}_{0}}} u_{N}(z)=\sup _{\partial \mathbb{C}_{0}} u_{N}(z) .
$$

Since $\left\|D^{z}\right\|=\left\|D^{-z}\right\|=1$ for $z \in \partial \mathbb{C}_{0}$, we have $\left\|A_{N}(z)\right\| \leq\left\|A_{N}\right\|$ for $z \in \partial \mathbb{C}_{0}$, and we get:

$$
\sup _{\overline{\mathbb{C}_{0}}} u_{N}(z) \leq\left\|A_{N}\right\| \leq\|A\|
$$

In particular $u_{N}(1) \leq\|A\|$, and, letting $N$ going to infinity, we get $\left\|D^{-1} A D\right\| \leq$ $\|A\|$.

Proof of Theorem 3.7. First, if $\left|\varphi^{\prime}(0)\right|=1$, we have $\varphi(z)=\alpha z$ for some $\alpha$ with $|\alpha|=1$, and the result is trivial.

So, we assume that $\left|\varphi^{\prime}(0)\right|<1$. Then, by Lemma 3.8, there exists $\rho>0$ such that, for all $m, n$ :

$$
\left|\widehat{\varphi^{n}}(m)\right| \leq \exp \left(-\frac{1}{2}[(1+\rho) n-m]\right)
$$

Since $\varphi(0)=0$, we also know that $\widehat{\varphi^{n}}(m)=0$ if $m<n$.
Take $\delta=\rho / 2$ and use property (3.7): there exists $C>0$ such that:

$$
\frac{\beta_{m}}{\beta_{n}} \leq C \quad \text { when } m \geq(1+\delta) n
$$

Define now a new sequence $\gamma=\left(\gamma_{n}\right)$ as:

$$
\gamma_{n}=\max \left\{\beta_{n}, \sup _{m>(1+\delta) n} \beta_{m}\right\}
$$

We have:

1) $\beta_{n} \leq \gamma_{n} \leq C \beta_{n}$;
2) $\gamma_{m} \leq \gamma_{n} \quad$ if $m \geq(1+\delta) n$.

Item 1) implies that $H^{2}(\gamma)=H^{2}(\beta)$, and we are reduced to prove that $C_{\varphi}: H^{2}(\gamma) \rightarrow H^{2}(\gamma)$ is bounded.

Let $A=\left(a_{m, n}\right)=\left(\widehat{\varphi^{n}}(m)\right)$. We have to prove that

$$
B=\left(\gamma_{m}^{1 / 2} \gamma_{n}^{-1 / 2} a_{m, n}\right)_{m, n}
$$

represents a bounded operator on $\ell_{2}$.

Define the matrix

$$
A_{1}=\left(a_{m, n} \mathbb{1}_{\{(m, n) ; m \leq(1+\delta) n\}}\right)_{m, n}
$$

and set $A_{2}=A-A_{1}$. Define analogously $B_{1}$ and $B_{2}=B-B_{1}$.
Then $A_{1}$ is a Hilbert-Schmidt operator, because (recall that $a_{m, n}=0$ if $m<n$ )

$$
\begin{aligned}
\sum_{n=1}^{\infty} \sum_{m=1}^{(1+\delta) n}\left|a_{m, n}\right|^{2} & \leq \sum_{n=1}^{\infty} \sum_{m=n}^{(1+\delta) n} \exp (-[(1+\rho) n-m]) \\
& \leq \sum_{n=1}^{\infty}(\delta n+1) \exp (-\delta n)<\infty
\end{aligned}
$$

Now, $\beta$ is bounded above and has a polynomial minoration, so, for some positive constants $C_{1}, C_{2}$, and $\alpha$, we have:

$$
\begin{aligned}
\sum_{n=1}^{\infty} \sum_{m=n}^{(1+\delta) n} \frac{\gamma_{m}}{\gamma_{n}}\left|a_{m, n}\right|^{2} & \leq \sum_{n=1}^{\infty} \sum_{m=n}^{(1+\delta) n} \frac{C_{1}}{n^{-\alpha}} \exp (-\delta n) \\
& \leq \sum_{n=1}^{\infty} C_{2} n^{\alpha+1} \exp (-\delta n)<\infty
\end{aligned}
$$

meaning that $B_{1}$ is a Hilbert-Schmidt operator.
Since $A$ is bounded, it follows that $A_{2}=A-A_{1}$ is bounded. Remark that, writing $A_{2}=\left(\alpha_{m, n}\right)_{m, n}$, we have, with $d_{n}=1 / \sqrt{\gamma_{n}}$ :

$$
d_{m}<d_{n} \quad \Longrightarrow \quad \gamma_{m}>\gamma_{n} \quad \Longrightarrow \quad m<(1+\delta) n \quad \Longrightarrow \quad \alpha_{m, n}=0
$$

Hence we can apply Lemma 3.9 to the matrix $A_{2}$, and it ensues that $B_{2}$ is bounded, and therefore that $B=B_{1}+B_{2}$ is bounded as well, as wanted.

We now can prove Theorem 3.3, as a corollary of Theorem 3.7.
Proof of Theorem 3.3. Define $\beta_{n}=1$ for $n \leq 3$ !, and, for $k \geq 3$ :

$$
\begin{cases}\beta_{n}=\frac{1}{k!} \quad \text { for } k!<n \leq(k+1)!-2 \text { and for } n=(k+1)! \\ \beta_{n}=\frac{1}{(k+1)!} & \text { for } n=(k+1)!-1\end{cases}
$$

Note that, for $m>n$, we have $\beta_{m}>\beta_{n}$ only if $n=(k+1)$ ! -1 and $m=(k+1)!=n+1$, for some $k \geq 3$.

However, $\beta$ is not essentially decreasing since, for every $k \geq 3$, we have $\beta_{n+1} / \beta_{n}=k+1$ if $n=(k+1)!-1$.

The sequence $\beta$ has a polynomial minoration because $\beta_{n} \geq 1 /(2 n)$ for all $n \geq 1$. In fact, for $k \geq 3$, we have $\beta_{n} \geq(k+1) / n \geq 1 / n$ if $k!<n \leq(k+1)!-2$ or if $n=(k+1)!$; and for $n=n=(k+1)!-1$, we have $n \beta_{n}=[(k+1)!-1] /(k+1)!\geq$ $1 / 2$.

Now, it remains to check (3.7) in order to apply Theorem 3.7 and finish the proof of Theorem 3.3. Note first that we have $\beta_{m} / \beta_{n} \leq 1$ if $m \geq n+2$. Next, for given $\delta>0$, there exists an integer $N$ such that $(1+\delta) n \geq n+2$ for every $n \geq N$, so $\beta_{m} / \beta_{n} \leq 1$ if $m \geq(1+\delta) n$ and $n \geq N$. It suffices to take $C=\max _{1 \leq n \leq N} \beta_{n+1} / \beta_{n}$ to obtain (3.7).

## 4 Necessity of the $\Delta_{2}$-condition

In this section, we will show that, for essentially decreasing sequences $\beta$, the $\Delta_{2}$-condition is necessary for having boundedness of composition operators on $H^{2}(\beta)$.
Theorem 4.1. Let $\beta$ be an essentially decreasing sequence and assume that, for some $a \in(0,1)$, $T_{a}$ induces a bounded composition operator on $H^{2}(\beta)$. Then $\beta$ satisfies the $\Delta_{2}$-condition.

In order to prove Theorem 4.1, we need several preliminary lemmas. The first one is standard, but we give it for convenience.

Lemma 4.2. Let $a \in(0,1)$ and let

$$
P_{-a}(x)=\frac{1-a^{2}}{1+2 a \cos x+a^{2}}
$$

be the Poisson kernel at the point $-a$. Then, for all $x \in[-\pi, \pi]$ :

$$
\begin{equation*}
T_{a}\left(\mathrm{e}^{i x}\right)=\exp \left[i h_{a}(x)\right] \tag{4.1}
\end{equation*}
$$

where

$$
\begin{equation*}
h_{a}(x)=\int_{0}^{x} P_{-a}(t) d t \tag{4.2}
\end{equation*}
$$

Proof. For $t \in[-\pi, \pi]$, write:

$$
\psi(t):=\frac{\mathrm{e}^{i t}+a}{1+a \mathrm{e}^{i t}}=\exp (i u(t))
$$

with $u$ a real-valued, $\mathcal{C}^{1}$ function on $[-\pi, \pi]$ such that $u(0)=0$. This is possible since $\left|\psi\left(\mathrm{e}^{i t}\right)\right|=1$ and $\psi(0)=1$. Differentiating both sides with respect to $t$, we get:

$$
i \mathrm{e}^{i t} \frac{1-a^{2}}{\left(1+a \mathrm{e}^{i t}\right)^{2}}=i u^{\prime}(t) \frac{\mathrm{e}^{i t}+a}{1+a \mathrm{e}^{i t}} .
$$

This implies

$$
u^{\prime}(t)=\frac{1-a^{2}}{\left|1+a \mathrm{e}^{i t}\right|^{2}}=P_{-a}(t)
$$

and the result follows since $u(0)=0=h_{a}(0)$.

### 4.1 Main lemma

In this section, we state and prove the following lemma. The proof of this lemma is delicate, uses Lemma 4.2 and a van der Corput type estimate, inspired from [21, pp. 72-73]. We thank R. Zarouf [22] for interesting recent informations in this respect, related to his joint work with O. Szehr on the Schäffer problem (see [20]; see also the forthcoming thesis of K. Fouchet [6] and paper [1]). A similar estimate on Taylor coefficients of high powers of Blaschke factors is needed by these authors, even if they were primarily concerned with upper bounds.

Recall that we have set:

$$
\begin{equation*}
\left[T_{a}(z)\right]^{n}=\sum_{m=0}^{\infty} a_{m, n} z^{m} \tag{4.3}
\end{equation*}
$$

Lemma 4.3. Let $a \in(0,1)$. We set:

$$
\begin{equation*}
\tau=\frac{1+a}{1-a}>1 \tag{4.4}
\end{equation*}
$$

and write:

$$
\begin{equation*}
\tau^{-1}=1-3 \mu \tag{4.5}
\end{equation*}
$$

with $\mu=\mu_{a} \in(0,1 / 3)$. For every fixed positive integer $n$, let:

$$
\begin{equation*}
J_{n}=[(1-2 \mu) n,(1-\mu) n] . \tag{4.6}
\end{equation*}
$$

Then, there exists $\delta=\delta_{a}>0$ such that, for every $n$ large enough, there exists a set of indices $E \subseteq J_{n}$ with cardinality $|E| \geq \delta n$ and such that:

$$
\begin{equation*}
m \in E \quad \Longrightarrow \quad\left|a_{m, n}\right| \geq \delta n^{-1 / 2} \tag{4.7}
\end{equation*}
$$

As a corollary of this lemma, we have the following result.
Proposition 4.4. For the weight $\beta$ constructed in the proof of Theorem 3.3, no automorphism $T_{a}$ with $0<a<1$ can be bounded.

Proof. When $T_{a}$ is bounded, we have, with $M=\left\|C_{T_{a}}\right\|$, for every $n$ :

$$
\begin{equation*}
\sum_{m=0}^{\infty}\left|a_{m, n}\right|^{2} \beta_{m}=\left\|T_{a}{ }^{n}\right\|^{2}=\left\|C_{T_{a}}\left(z^{n}\right)\right\|^{2} \leq\left\|C_{T_{a}}\right\|^{2}\left\|z^{n}\right\|^{2}=M^{2} \beta_{n} \tag{4.8}
\end{equation*}
$$

For the weight $\beta$ constructed in the proof of Theorem 3.3, we are going to see that this condition is not satisfied for $n=(k+1)!+1:=n_{k}$.

In fact, by Lemma 4.3, there exist constants $0<\alpha_{1}<\alpha_{2}<1$ and $\gamma, \delta>0$, depending only on $a$, and a set $E_{k}$ of integers such that $E_{k} \subseteq\left[\alpha_{1} n_{k}, \alpha_{2} n_{k}\right]$ and $\left|E_{k}\right| \geq \gamma n_{k}$ for which

$$
\left|a_{m, n}\right| \geq \delta n_{k}^{-1 / 2} \quad \text { for } m \in E_{k}
$$

For $k$ large enough, we have $\left[\alpha_{1} n_{k}, \alpha_{2} n_{k}\right] \subseteq[k!+1,(k+1)!-1] \backslash\{(k+1)!-1\}$; hence the left-hand side of (4.8) is larger than

$$
\frac{\delta^{2}}{k!} \sum_{m \in E_{k}} \frac{1}{n_{k}} \geq \frac{\delta^{2}}{k!} \gamma
$$

Since the right-hand side of (4.8) is $M^{2} /(k+1)$ !, that is much smaller, $T_{a}$ cannot be bounded.

To prove Lemma 4.3, we will use a variant of [21, Lemma 4.6 p. 72] on the stationary phase method. It is observed in [21, p. 90] that some error term $O\left(\lambda_{2}^{-4 / 5} \lambda_{3}^{1 / 5}\right)$ to come can be replaced by $O\left(\lambda_{2}^{-1} \lambda_{3}^{1 / 3}\right)$, but this refinement is not needed here. However, a careful reading of the proof in [21, p. 72] gives the version below, which allows the derivative $F^{\prime}$ of $F$ to vanish at some point, as occurs in our situation. For sake of completeness, we will give a proof, however postponed.

Theorem 4.5 (Stationary phase). Let $F$ be real function on the interval $[A, B]$, with continuous derivatives up to the third order and $F^{\prime \prime}>0$ throughout $] A, B[$. Let $c$ be the unique point in $] A, B\left[\right.$ where $F^{\prime}(c)=0$. Assume that, for some positive numbers $\lambda_{2}, \lambda_{3}$, and $\eta$, the following assertions hold:

1) $[c-\eta, c+\eta] \subseteq[A, B]$;
2) $F^{\prime \prime}(x) \geq \lambda_{2}$ for all $x \in[c-\eta, c+\eta]$;
3) $\left|F^{\prime \prime \prime}(x)\right| \leq \lambda_{3}$ for all $x \in[A, B]$.

Then:

$$
\begin{equation*}
\int_{A}^{B} \mathrm{e}^{i F(x)} d x=\sqrt{2 \pi} \frac{\mathrm{e}^{i(F(c)+\pi / 4)}}{\left|F^{\prime \prime}(c)\right|^{1 / 2}}+O\left(\frac{1}{\eta \lambda_{2}}+\eta^{4} \lambda_{3}\right) \tag{4.9}
\end{equation*}
$$

where the $O$ involves an absolute constant.

Proof of Lemma 4.3. We turn to the problem of bounding $a_{m, n}$ from below, in the case $m \in J$, and only in that case. Since $\inf _{[0, \pi]} P_{-a}=\tau^{-1}<\sup _{[0, \pi]} P_{-a}=$ $\tau$, there exists a unique point $x_{m}=x_{m, n} \in[0, \pi]$ such that

$$
n P_{-a}\left(x_{m}\right)-m=n \frac{\left(1-a^{2}\right)}{1+2 a \cos x_{m}+a^{2}}-m=0
$$

or else:

$$
\begin{equation*}
\cos x_{m}=\frac{n}{m} \frac{1-a^{2}}{2 a}-\frac{1+a^{2}}{2 a} \tag{4.10}
\end{equation*}
$$

The point is that if $m \in J, x_{m}$ can approach neither 0 nor $\pi$, so that $\sin x_{m} \geq \delta_{a}>0$; in fact, otherwise $m / n$ approaches $\tau^{ \pm 1}$, which is impossible by
definition of $J$. With $h_{a}$ the function of Lemma 4.2, the Fourier formulas give, since $a_{m, n}$ is real, or since $h_{a}(x)-m x$ is odd:

$$
2 \pi a_{m, n}=\int_{-\pi}^{\pi} \exp i\left[n h_{a}(x)-m x\right] d x=2 \mathfrak{R e} I_{m, n}
$$

where

$$
\begin{equation*}
I_{m, n}=\int_{0}^{\pi} \exp i\left[n h_{a}(x)-m x\right] d x . \tag{4.11}
\end{equation*}
$$

Write:

$$
\begin{equation*}
I_{m, n}=\int_{0}^{\pi} \exp [i F(x)] d x \tag{4.12}
\end{equation*}
$$

with:

$$
\begin{equation*}
F(x)=n h_{a}(x)-m x=n \int_{0}^{x} P_{-a}(t) d t-m x \tag{4.13}
\end{equation*}
$$

We have:

$$
\begin{equation*}
F^{\prime}(x)=n P_{-a}(x)-m . \tag{4.14}
\end{equation*}
$$

We will now proceed in two steps, first giving good lower bounds for $\left|I_{m, n}\right|$, then showing that the argument of $I_{m, n}$ is often far from $\pi / 2 \bmod \pi$. Then, we will be done.

First step. We will prove that:

$$
\begin{equation*}
I_{m, n}=\sqrt{2 \pi} n^{-1 / 2} \frac{\mathrm{e}^{i\left(F\left(x_{m}\right)+\pi / 4\right)}}{\sqrt{\left|h_{a}^{\prime \prime}\left(x_{m}\right)\right|}}+O\left(n^{-3 / 5}\right) \tag{4.15}
\end{equation*}
$$

where the $O$ only depends on $a$.
Note that $3 / 5>1 / 2$ and $F^{\prime \prime}=n h_{a}^{\prime \prime}$.
To get (4.15), we will show that Theorem 4.5 is applicable with:

$$
[A, B]=[0, \pi], \quad c=x_{m}, \quad \lambda_{2}=\kappa_{0} n, \quad \lambda_{3}=C_{0} n, \quad \eta=\left(\lambda_{2} \lambda_{3}\right)^{-1 / 5}
$$

The parameter $\eta$ is chosen in order to make both error terms in Theorem 4.5 equal: $\frac{1}{\eta \lambda_{2}}=\eta^{4} \lambda_{3}$; so:

$$
\eta=\kappa n^{-2 / 5}
$$

and

$$
\begin{equation*}
\frac{1}{\eta \lambda_{2}}+\eta^{4} \lambda_{3}=\widetilde{\kappa} n^{-3 / 5}=O\left(n^{-3 / 5}\right) \tag{4.16}
\end{equation*}
$$

(with $\kappa=\left(\kappa_{0} C_{0}\right)^{-1 / 5}$ and $\left.\widetilde{\kappa}=2 / \kappa_{0} \kappa\right)$.

The slight technical difficulty encountered here is that $F^{\prime \prime}(x)$ vanishes at 0 and $\pi$. But Theorem 4.5 covers this case. We have

$$
F^{\prime \prime}(x)=n P_{-a}^{\prime}(x)=2 a\left(1-a^{2}\right) \frac{\sin x}{\left(1+2 a \cos x+a^{2}\right)^{2}} n,
$$

and there are some positive $\kappa_{0}$ and $\sigma$ such that

$$
\begin{equation*}
F^{\prime \prime}(x) \geq \kappa_{0} n=\lambda_{2} \quad \text { for } x \in[\sigma, \pi-\sigma] \tag{4.17}
\end{equation*}
$$

Now (for $n$ large enough), $\left[x_{m}-\eta, x_{m}+\eta\right] \subseteq[\sigma, \pi-\sigma]$. Hence the assumptions 1) and 2) of Theorem 4.5 are satisfied.

Finally, since $F=n h_{a}$, and $h_{a}$ is $\mathcal{C}^{\infty}$ on $\mathbb{R}$, we have, for all $x \in[0, \pi]$ :

$$
\left|F^{\prime \prime \prime}(x)\right| \leq C_{0} n=\lambda_{3},
$$

and assertion 3) of Theorem 4.5 holds.
With (4.16) this ends the proof of (4.15), once we remarked that $n h_{a}^{\prime \prime}\left(x_{m}\right)=$ $F^{\prime \prime}\left(x_{m}\right)$.

Note that, since $\left|h_{a}^{\prime \prime}\left(x_{m}\right)\right| \leq M_{a}$, we get that $\left|I_{m, n}\right| \geq \delta n^{-1 / 2}$ when $m \in J$.
Second step. The mean-value theorem gives, for $m \in J$ :

$$
\begin{equation*}
\left|\sin x_{m}\right| \geq \delta \quad \text { and } \quad x_{m+1}-x_{m} \approx \cos x_{m}-\cos x_{m+1} \tag{4.18}
\end{equation*}
$$

We also have, for $x \in \mathcal{J}=[1-2 \mu, 1-\mu]$, with another constant $\delta$ :

$$
\begin{equation*}
\delta \leq P_{-a}^{\prime}(x)=2 a\left(1-a^{2}\right) \frac{\sin x}{\left(1+2 a \cos x+a^{2}\right)^{2}} \leq \delta^{-1} \tag{4.19}
\end{equation*}
$$

We now claim that

$$
\begin{equation*}
x_{m+1}-x_{m} \approx n^{-1} \quad \text { for } m \in J \tag{4.20}
\end{equation*}
$$

Indeed, since $m \in J$, we have, using (4.10):

$$
\cos x_{m}-\cos x_{m+1}=\frac{1-a^{2}}{2 a} \frac{n}{m(m+1)} \approx \frac{n}{m^{2}} \approx n^{-1}
$$

In view of (4.18), this proves (4.20).
Now, according to (4.15), when $m \in J$, the main term in $I_{m, n}$ is

$$
A_{m, n}:=n^{-1 / 2} \frac{\sqrt{2 \pi}}{\sqrt{\left|h_{a}^{\prime \prime}\left(x_{m}\right)\right|}} \mathrm{e}^{i\left(F\left(x_{m}\right)+\pi / 4\right)},
$$

and its argument $\theta_{m}$ is $F\left(x_{m}\right)+\pi / 4$. Going from $m$ to $m+1$, the variation $F\left(x_{m+1}\right)-F\left(x_{m}\right)$ of this argument is
$\theta_{m+1}-\theta_{m}=n \int_{x_{m}}^{x_{m+1}}\left(P_{-a}(t)-\frac{m}{n}\right) d t=n \int_{x_{m}}^{x_{m+1}}\left(P_{-a}(t)-P_{-a}\left(x_{m}\right)\right) d t$.

But, due to (4.19), this implies:

$$
\theta_{m+1}-\theta_{m} \approx n \int_{x_{m}}^{x_{m+1}}\left(t-x_{m}\right) d t \approx n\left(x_{m+1}-x_{m}\right)^{2} \approx n^{-1}
$$

The variation of $\theta_{m}$ is thus regular, like that of the argument of $n$-th roots of unity. As a consequence, for a positive proportion $E$ of the indices $m \in J$, the argument $\theta_{m}$ will belong to a subarc of $\mathbb{T}$ which lies $\delta$-apart from $\pm \pi / 2$, implying $\cos \theta_{m} \geq \delta$, or else:

$$
|E| \geq \delta n
$$

and, for all $m \in E$ :

$$
\mathfrak{R e} A_{m, n} \geq \delta\left|A_{m, n}\right| \geq \delta n^{-1 / 2}
$$

It follows that, for $m \in E$ :

$$
\mathfrak{R e} I_{m, n} \geq \delta n^{-1 / 2}-C n^{-3 / 5} \geq \widetilde{\delta} n^{-1 / 2}
$$

Since $a_{m, n}=\pi^{-1} \mathfrak{R e} I_{m, n}$, that ends the proof of Lemma 4.3.

### 4.2 Proof of Theorem 4.5

The following lemma can be found in [15, Lemma 1, page 47].
Lemma 4.6. Let $F:[u, v] \rightarrow \mathbb{R}$, with $u<v$, be a $C^{2}$ - function with $F^{\prime \prime}>0$, and $F^{\prime}$ not vanishing on $[u, v]$. Let

$$
J=\int_{u}^{v} e^{i F(x)} d x
$$

Then:
a) if $F^{\prime}>0$ on $[u, v]$, then $|J| \leq \frac{2}{F^{\prime}(u)}$;
b) If $F^{\prime}<0$ on $[u, v]$, then $|J| \leq \frac{2}{\left|F^{\prime}(v)\right|}$.

Write now the integral $I$ of Theorem 4.5 on $[A, B]$ as $I=I_{1}+I_{2}+I_{3}$ with:

$$
I_{1}=\int_{A}^{c-\eta} \mathrm{e}^{i F(x)} d x, \quad I_{2}=\int_{c-\eta}^{c+\eta} \mathrm{e}^{i F(x)} d x, \quad I_{3}=\int_{c+\eta}^{B} \mathrm{e}^{i F(x)} d x
$$

Lemma 4.6 with $u=A$ and $v=c-\eta$ implies:

$$
\begin{equation*}
\left|I_{1}\right| \leq \frac{2}{\left|F^{\prime}(c-\eta)\right|} \leq \frac{2}{\eta \lambda_{2}} \tag{4.21}
\end{equation*}
$$

where, for the last inequality, we just have to write

$$
\left|F^{\prime}(c-\eta)\right|=F^{\prime}(c)-F^{\prime}(c-\eta)=\eta F^{\prime \prime}(\xi)
$$

for some $\xi \in[c-\eta, c]$ so that $F^{\prime \prime}(\xi) \geq \lambda_{2}$.

Similarly, Lemma 4.6 with $u=c+\eta$ and $v=B$ implies

$$
\begin{equation*}
\left|I_{3}\right| \leq \frac{2}{F^{\prime}(c+\eta)} \leq \frac{2}{\eta \lambda_{2}} \tag{4.22}
\end{equation*}
$$

We can now estimate $I_{2}$. The Taylor formula shows that

$$
F(x)=F(c)+\frac{(x-c)^{2}}{2} F^{\prime \prime}(c)+R
$$

with

$$
|R| \leq \frac{|x-c|^{3}}{6} \lambda_{3}
$$

Hence

$$
I_{2}=\mathrm{e}^{i F(c)} \int_{0}^{\eta} 2 \exp \left(\frac{i}{2} x^{2} F^{\prime \prime}(c)\right) d x+S
$$

with

$$
|S| \leq \lambda_{3} \int_{0}^{\eta} \frac{x^{3}}{3} d x=\frac{\eta^{4}}{12} \lambda_{3}
$$

Finally, set

$$
K=\int_{0}^{\eta} 2 \exp \left(\frac{i}{2} x^{2} F^{\prime \prime}(c)\right) d x
$$

We make the change of variable $x=\sqrt{\frac{2}{F^{\prime \prime}(c)}} \sqrt{t}$. Recall that $\int_{0}^{\infty} \frac{\mathrm{e}^{i t}}{\sqrt{t}} d t=$ $\sqrt{\pi} \mathrm{e}^{i \pi / 4}$ is the classical Fresnel integral, and that an integration by parts gives, for $m>0$ :

$$
\left|\int_{m}^{\infty} \frac{\mathrm{e}^{i t}}{\sqrt{t}} d t\right| \leq \frac{2}{\sqrt{m}}
$$

Therefore, with $m=\frac{\eta^{2}}{2} F^{\prime \prime}(c)$ :

$$
K=\sqrt{\frac{2}{F^{\prime \prime}(c)}} \int_{0}^{m} \frac{\mathrm{e}^{i t}}{\sqrt{t}} d t=\sqrt{\frac{2 \pi}{F^{\prime \prime}(c)}} \mathrm{e}^{i \pi / 4}+R_{m}
$$

with

$$
\left|R_{m}\right| \leq C \sqrt{\frac{1}{F^{\prime \prime}(c)}} \frac{1}{\sqrt{m}} \leq \frac{C}{\eta \lambda_{2}}
$$

All in all, we proved that

$$
\begin{equation*}
I_{2}=\sqrt{\frac{2 \pi}{F^{\prime \prime}(c)}} \exp [i(F(c)+\pi / 4)]+O\left(\frac{1}{\eta \lambda_{2}}+\eta^{4} \lambda_{3}\right) \tag{4.23}
\end{equation*}
$$

and the same estimate holds for $I$, thanks to (4.21) and (4.22).
We have hence proved Theorem 4.5.

### 4.3 Proof of Theorem 4.1

We may, and do, assume that $\beta$ is non-increasing.
Set $M=\left\|C_{T_{a}}\right\|$. We have:

$$
\sum_{m=0}^{\infty}\left|a_{m, n}\right|^{2} \beta_{m}=\left\|T_{a}{ }^{n}\right\|^{2}=\left\|C_{T_{a}}\left(z^{n}\right)\right\|^{2} \leq\left\|C_{T_{a}}\right\|^{2}\left\|z^{n}\right\|^{2}=M^{2} \beta_{n}
$$

so, by Lemma 4.3 , since $\beta$ is non-increasing and $E \subseteq J=[(1-2 \mu) n,(1-\mu) n]$ :

$$
M^{2} \beta_{n} \geq \sum_{m \in E}\left|a_{m, n}\right|^{2} \beta_{m} \geq \delta^{2} n^{-1} \sum_{m \in E} \beta_{m} \geq \delta^{2} n^{-1}|E| \beta_{(1-\mu) n}
$$

where we have set, for $x$ not an integer, $\beta_{x}=\beta_{k}$ with $k$ the least integer greater than $x$.

That implies, for all integers $n \geq 1$ :

$$
\beta_{n} \geq\left(\delta^{2} / M^{2}\right) n^{-1}(\delta n) \beta_{(1-\mu) n} \geq c \beta_{(1-\mu) n}
$$

Let $r \geq 1$ such that $(1-\mu)^{r} \leq 1 / 2$; we have:

$$
\beta_{n} \geq c^{r} \beta_{(1-\mu)^{r} n} \geq c^{r} \beta_{n / 2}
$$

so $\beta$ satisfies the $\Delta_{2}$-condition.

## 5 Some results on multipliers

The set $\mathcal{M}\left(H^{2}(\beta)\right)$ of multipliers of $H^{2}(\beta)$ is by definition the vector space of functions $h$ analytic on $\mathbb{D}$ and such that $h f \in H^{2}(\beta)$ for all $f \in H^{2}(\beta)$. When $h \in \mathcal{M}\left(H^{2}(\beta)\right)$, the operator $M_{h}$ of multiplication by $h$ is bounded on $H^{2}(\beta)$ by the closed graph theorem. The space $\mathcal{M}\left(H^{2}(\beta)\right)$ equipped with the operator norm is a Banach space. We note the obvious property:

$$
\begin{equation*}
\mathcal{M}\left(H^{2}(\beta)\right) \hookrightarrow H^{\infty} \quad \text { contractively. } \tag{5.1}
\end{equation*}
$$

Indeed, if $h \in \mathcal{M}\left(H^{2}(\beta)\right)$, we easily get for all $w \in \mathbb{D}$ :

$$
M_{h}^{*}\left(K_{w}\right)=\overline{h(w)} K_{w}
$$

so that taking norms and simplifying, we are left with $|h(w)| \leq\left\|M_{h}\right\|$, showing that $h \in H^{\infty}$ with $\|h\|_{\infty} \leq\left\|M_{h}\right\|$.
Proposition 5.1. We have $\mathcal{M}\left(H^{2}(\beta)\right)=H^{\infty}$ isomorphically if and only if $\beta$ is essentially decreasing.
Proof. The sufficient condition is proved in [13, beginning of the proof of Proposition 3.16]. For the necessity, we have $\left\|M_{h}\right\| \approx\|h\|_{\infty}$ for every $h \in H^{\infty}$. Now, for $m>n$ (recall that $e_{n}(z)=z^{n}$ ):

$$
e_{m}(z)=z^{m-n} z^{n}=\left(M_{e_{m-n}} e_{n}\right)(z)
$$

so, since $\left\|M_{e_{m-n}}\right\| \leq C\left\|e_{m-n}\right\|_{\infty}=C$ for some positive constant $C$ :

$$
\beta_{m}=\left\|e_{m}\right\|^{2} \leq C^{2}\left\|e_{n}\right\|^{2}=C^{2} \beta_{n} .
$$

In [13, Section 3.6], we gave the following notion of admissible Hilbert space of analytic functions.
Definition 5.2. A Hilbert space $H$ of analytic functions on $\mathbb{D}$, containing the constants, and with reproducing kernels $K_{a}, a \in \mathbb{D}$, is said admissible if:
(i) $H^{2}$ is continuously embedded in $H$;
(ii) $\mathcal{M}(H)=H^{\infty}$;
(iii) the automorphisms of $\mathbb{D}$ induce bounded composition operators on $H$;
(iv) $\frac{\left\|K_{a}\right\|_{H}}{\left\|K_{b}\right\|_{H}} \leq h\left(\frac{1-|b|}{1-|a|}\right)$ for $a, b \in \mathbb{D}$, where $h: \mathbb{R}^{+} \rightarrow \mathbb{R}^{+}$is an nondecreasing function.

We proved in that paper that every weighted Hilbert space $H^{2}(\beta)$ with $\beta$ non-increasing is admissible, under the additional hypothesis that the automorphisms of $\mathbb{D}$ induce bounded composition operators. In view of Theorem 3.4, we get the following result.

Proposition 5.3. Let $\beta$ be essentially decreasing that satisfies the $\Delta_{2}$-condition. Then $H^{2}(\beta)$ is admissible.

Let us give a different proof.
Proof. Because $\beta$ is essentially decreasing, item (i) holds, as well as item (ii), by Proposition 5.1. Item (iii) is Theorem 3.4. It remains to show (iv). We may assume that $\beta$ is non-increasing.

Let $0<s<r<1$.
Without loss of generality, we may assume that $r, s \geq 1 / 2$. It is enough to prove:

$$
\begin{equation*}
\left\|K_{r}\right\|^{2} \leq C\left\|K_{r^{2}}\right\|^{2} \tag{5.2}
\end{equation*}
$$

for some constant $C>1$. Indeed, iteration of (5.2) gives:

$$
\left\|K_{r}\right\|^{2} \leq C^{k}\left\|K_{r^{2}}\right\|^{2}
$$

and if $k$ is the smallest integer such that $r^{2^{k}} \leq s$, we have $2^{k-1} \log r>\log s$ and $2^{k} \leq D \frac{1-s}{1-r}$ where $D$ is a numerical constant. Writing $C=2^{\alpha}$ with $\alpha>1$, we obtain:

$$
\left(\frac{\left\|K_{r}\right\|}{\left\|K_{s}\right\|}\right)^{2} \leq C^{k}=\left(2^{k}\right)^{\alpha} \leq D^{\alpha}\left(\frac{1-s}{1-r}\right)^{\alpha}
$$

To prove (5.2), we pick some $M>1$ such that $\beta_{2 n} \geq M^{-1} \beta_{n}$ for all $n \geq 1$ and write $t=r^{2}$. We have:

$$
\left\|K_{r}\right\|^{2}=\frac{1}{\beta_{0}}+\sum_{n=1}^{\infty} \frac{t^{2 n}}{\beta_{2 n}}+\sum_{n=1}^{\infty} \frac{t^{2 n-1}}{\beta_{2 n-1}}
$$

implying, since $\beta_{2 n-1} \geq \beta_{2 n} \geq M^{-1} \beta_{n}$ and $t^{2 n-1} \leq 4 t^{2 n}$ :

$$
\left\|K_{r}\right\|^{2} \leq \frac{1}{\beta_{0}}+M \sum_{n=1}^{\infty} \frac{t^{2 n}}{\beta_{n}}+4 M \sum_{n=1}^{\infty} \frac{t^{2 n}}{\beta_{n}} \leq 5 M\left\|K_{t}\right\|^{2}
$$

The notion of admissible Hilbert space $H$ is useful for the set of conditional multipliers:

$$
\mathcal{M}(H, \varphi)=\{w \in H ; w(f \circ \varphi) \in H \text { for all } f \in H\}
$$

As a corollary of [13, Theorem 3.18] we get:
Corollary 5.4. Let $\beta$ be essentially decreasing and satisfying the $\Delta_{2}$-condition. Then:

1) $\mathcal{M}\left(H^{2}, \varphi\right) \subseteq \mathcal{M}\left(H^{2}(\beta), \varphi\right)$;
2) $\mathcal{M}\left(H^{2}(\beta), \varphi\right)=H^{2}(\beta)$ if and only if $\|\varphi\|_{\infty}<1$;
3) $\mathcal{M}\left(H^{2}(\beta), \varphi\right)=H^{\infty}$ if and only if $\varphi$ is a finite Blaschke product.

## 6 Miscellaneous remarks

Some of the results of this paper can slightly be improved.

### 6.1 Conditions on the weight $\beta$

First, we say that a sequence $\left(\beta_{n}\right)$ of positive numbers is slowly oscillating if there if a function $\rho:(0, \infty) \rightarrow(0, \infty)$ that is bounded on each compact subset of $(0, \infty)$ for which:

$$
\frac{\beta_{m}}{\beta_{n}} \leq \rho\left(\frac{m}{n}\right)
$$

This clearly amounts to say that, for some positive constants $C_{1}<C_{2}$, we have:

$$
C_{1} \leq \frac{\beta_{m}}{\beta_{n}} \leq C_{2} \quad \text { when } n / 2 \leq m \leq 2 n
$$

Every essentially decreasing sequence with the $\Delta_{2}$-condition is slowly oscillating.

Proposition 6.1. The following holds:

1) every slowly oscillating sequence has a polynomial minoration;
2) there are bounded sequences which are slowly oscillating, but not essentially decreasing.

Proof. 1) is clear, because if $2^{j} \leq n<2^{j+1}$, then

$$
\beta_{n} \geq C^{-1} \beta_{2^{j}} \geq C^{-j-1} \beta_{1} \geq C^{-1} \beta_{1} n^{-\alpha}
$$

with $\alpha=\log C / \log 2$.
2) We define $\beta_{n}$ as follows. Let $\left(a_{k}\right)$ be an increasing sequence of positive square integers such that $\lim _{k \rightarrow \infty} a_{k+1} / a_{k}=\infty$, for example $a_{k}=4^{k^{2}}$, and let $b_{k}=\sqrt{a_{k} a_{k+1}}$; with our choice, this is an integer and we clearly have $a_{k}<b_{k}<a_{k+1}$. We set:

$$
\beta_{n}= \begin{cases}a_{k} / n & \text { for } a_{k} \leq n<b_{k} \\ \left(a_{k} / b_{k}^{2}\right) n=\left(1 / a_{k+1}\right) n & \text { for } b_{k} \leq n<a_{k+1}\end{cases}
$$

This sequence $\left(\beta_{n}\right)$ is slowly oscillating by construction. Indeed, it suffices to check that for $a_{k} \leq n / 2<b_{k} \leq n<a_{k+1}$, the quotient $\beta_{m} / \beta_{n}$ remains lower and upper bounded when $n / 2 \leq m \leq n$. But for $n / 2 \leq m<b_{k}$, we have

$$
\frac{\beta_{m}}{\beta_{n}}=\frac{a_{k} / m}{n / a_{k+1}}=\frac{a_{k} a_{k+1}}{m n}=\frac{b_{k}^{2}}{m n}
$$

which is $\leq 2 b_{k}^{2} / n^{2} \leq 2$ and $\geq b_{k}^{2} / n^{2} \geq(n / 2)^{2} / n^{2}=1 / 4$; and for $b_{k} \leq m$, we have

$$
\frac{\beta_{m}}{\beta_{n}}=\frac{m / a_{k+1}}{n / a_{k+1}}=\frac{m}{n} \in[1 / 2,1] .
$$

However, though $\left(\beta_{n}\right)$ is bounded, since $\beta_{n} \leq 1$ for $a_{k} \leq n<b_{k}$ and, for $b_{k} \leq n<a_{k+1}$,

$$
\beta_{n} \leq \beta_{a_{k+1}-1}=\frac{1}{a_{k+1}}\left(a_{k+1}-1\right) \leq 1
$$

it is not essentially decreasing, since

$$
\frac{\beta_{a_{k+1}-1}}{\beta_{b_{k}}}=\frac{1}{\sqrt{a_{k} a_{k+1}}}\left(a_{k+1}-1\right) \sim \sqrt{\frac{a_{k+1}}{a_{k}}} \underset{k \rightarrow \infty}{\longrightarrow} \infty .
$$

By a slight modification (change the value of the constants in the definition of $\beta_{n}$ ), we could obtain a sequence which is slowly oscillating, tends to zero, yet again not essentially decreasing.

Now, Theorem 3.4 admits the following variant.
Theorem 6.2. Let $\left(\beta_{n}\right)$ be a sequence of positive numbers which is bounded above and slowly oscillating. Then all symbols that extend analytically in a neighborhood of $\overline{\mathbb{D}}$ induce a bounded composition operator on $H^{2}(\beta)$.

It is the case, for example, for finite Blaschke products.
The proof follows that of Theorem 3.4, with the help of the following lemma.
Lemma 6.3. Let $\left(\beta_{n}\right)$ be a sequence of positive numbers which is bounded above and slowly oscillating. Let $A=\left(a_{m, n}\right)_{m, n}$ be the matrix of a bounded operator on $\ell_{2}$. Assume that, for constants $C>1$, and $a, b$, we have:

1) $\left|a_{m, n}\right| \leq a \mathrm{e}^{-b n}$ for $m \leq C^{-1} n$;
2) $\left|a_{m, n}\right| \leq a \mathrm{e}^{-b m}$ for $m \geq C n$.

Then the matrix $\widetilde{A}=\left(a_{m, n} \sqrt{\frac{\beta_{m}}{\beta_{n}}}\right)$ also defines a bounded operator on $\ell_{2}$.

Sketch of proof. The matrix $\widetilde{A}$ is Hilbert-Schmidt far the diagonal since, with $\lambda \geq \beta_{n} \geq \delta n^{-\alpha}$, we have:

$$
\sum_{m<C^{-1} n}\left|a_{m, n}\right|^{2} \beta_{m} / \beta_{n} \leq \sum_{m<C^{-1} n} \lambda \delta^{-1} n^{\alpha}\left|a_{m, n}\right|^{2} \lesssim \sum_{n \geq 1} n^{\alpha+1} \mathrm{e}^{-b n}<\infty,
$$

and

$$
\sum_{m>C n}\left|a_{m, n}\right|^{2} \beta_{m} / \beta_{n} \leq \sum_{m>C n} \lambda \delta^{-1} n^{\alpha}\left|a_{m, n}\right|^{2} \lesssim \sum_{n \geq 1} n^{\alpha}\left(\sum_{m>C n} \mathrm{e}^{-b m}\right) .
$$

Since $\beta_{m} / \beta_{n}$ remains bounded from above and below around the diagonal, the matrix $\widetilde{A}$ behaves like $A$ near the diagonal.

Remark. The proof shows that, instead of 1) and 2), it is enough to have:

$$
\sum_{m<C^{-1} n} n^{\alpha+1}\left|a_{m, n}\right|^{2}<\infty \quad \text { and } \quad \sum_{m>C n} m^{\alpha}\left|a_{m, n}\right|^{2}<\infty .
$$

Moreover the proof also shows that when $\beta$ is slowly oscillating, if we set $E=\left\{(m, n) ; C^{-1} n \leq m \leq C n\right\}$, then the matrix $\left(\sqrt{\beta_{m} / \beta_{n}} \mathbb{1}_{E}(m, n)\right)$ is a Schur multiplier over all the bounded matrices, while Theorem 3.6 says that, if $\gamma=\left(\gamma_{n}\right)$ is non-increasing, the matrix $\left(\gamma_{m} / \gamma_{n}\right)$ is a Schur multiplier of all bounded lower-triangular matrices.

Proof of Theorem 6.2. For every symbol $\varphi$, let $M(r)=\sup _{|z|=r}|\varphi(z)|$ and write $M(1 / \mathrm{e})=\mathrm{e}^{-\delta}$, with $\delta>0$. Let $A$ be the matrix of $C_{\varphi}$, with respect to the canonical basis of $H^{2}$. The Cauchy inequalities give, if $m \leq(\delta / 2) n$ :

$$
\left|a_{m, n}\right| \leq[M(1 / \mathrm{e})]^{n} \mathrm{e}^{m} \leq \mathrm{e}^{m-\delta n} \leq \mathrm{e}^{-\delta / 2 n}
$$

When $\varphi$ is analytic in a neighborhood of $\overline{D(0, R)}$ with $R>1$, the Cauchy inequalities give, writing $M(R)=\mathrm{e}^{\rho}$ and $R=\mathrm{e}^{\delta}$, for $m \geq C n$, and a suitable constant $C$ (take $C=2 \rho^{\delta}$ for instance):

$$
\left|a_{m, n}\right| \leq \frac{[M(R)]^{n}}{R^{m}} \leq \mathrm{e}^{n \rho-\delta m} \leq \mathrm{e}^{-(\delta / 2) m} .
$$

We conclude with Lemma 6.3.
The proof of Theorem 4.1 actually gives a little bit more than its statement. Let $\left(\beta_{n}\right)$ be a sequence of positive numbers with limit zero. We say that $\left(\beta_{n}\right)$ is mean- $\Delta_{2}$ if, denoting by $\left(\beta_{n}^{*}\right)$ its non-increasing rearrangement, there is a positive constant $\delta$ such that:

$$
\begin{equation*}
\beta_{2 n} \geq \delta \frac{1}{n} \sum_{j=1}^{n} \beta_{j}^{*} . \tag{6.1}
\end{equation*}
$$

This condition is less restrictive than being slowly oscillating. Then, with the same proof, we have this variant of Theorem 4.1.

Theorem 6.4. Let $\beta=\left(\beta_{n}\right)$ be a bounded sequence of positive numbers. If some automorphism $T_{a}$ induces a bounded composition operator on $H^{2}(\beta)$, then $\beta$ is mean- $\Delta_{2}$.

Sketch of proof. We proved that, for some $E \subseteq[n / 2, n]$ with $|E| \gtrsim n$, we have $\beta_{2 n} \geq \delta \beta_{j}$ for $j \in E$. Since

$$
\sum_{j=1}^{n} \beta_{j}^{*}=\max _{|E|=n} \sum_{j \in E} \beta_{j}
$$

we get (6.1).

### 6.2 Singular inner functions

Let $a>0$ and let $I_{a}$ be the singular inner function defined by

$$
\begin{equation*}
I_{a}(z)=\exp \left(-a \frac{1+z}{1-z}\right)=\sum_{m=0}^{\infty} c_{m}(a) z^{m} \tag{6.2}
\end{equation*}
$$

If $n$ is a positive integer, we have $I_{n}(z)=\left[I_{1}(z)\right]^{n}$ and we write

$$
I_{n}(z)=\sum_{m=0}^{\infty} a_{m, n} z^{m}, \quad \text { with } a_{m, n}=c_{m}(n)
$$

We rely on the following lemma, familiar to experts in orthogonal polynomials and special functions, but maybe not so much as regards the uniformity, essential for our present purposes (see [16] or [12]).

Lemma 6.5. It holds

$$
\begin{equation*}
c_{m}(n)=c n^{1 / 4} m^{-3 / 4} \cos (2 \sqrt{2 n m}+\pi / 4)+R_{m}(n)=: M_{m}(n)+R_{m}(n) \tag{6.3}
\end{equation*}
$$

where $c=\pi^{-1 / 2} 2^{1 / 4}$ and where $\left|R_{m}(n)\right| \leq K \sqrt{n} m^{-5 / 4}$, with $K$ some numerical constant.

We use the following [16, p. 253] and [19, p. 198], where $L_{m}^{(\alpha)}$ denotes the generalized Laguerre polynomial of degree $m$ with parameter $\alpha$.

Theorem 6.6. With the notation of (6.2), we have

$$
c_{m}(a)=\mathrm{e}^{-a} L_{m}^{(-1)}(2 a)
$$

Moreover, we have, uniformly for $0<\varepsilon \leq x \leq M<\infty$ :

$$
L_{m}^{(\alpha)}(x)=\pi^{-1 / 2} \mathrm{e}^{x / 2} x^{-\alpha / 2-1 / 4} m^{\alpha / 2-1 / 4} \cos (2 \sqrt{m x}-\alpha \pi / 2-\pi / 4)+R_{m}(x)
$$

where $\left|R_{m}(x)\right| \leq K_{\alpha} m^{\alpha / 2-3 / 4}$, and $K_{\alpha}>0$ only depending on $\alpha$.

Now, using Theorem 6.6 with $\alpha=-1$ and $a=n$, we get Lemma 6.5. Actually, to get Lemma 6.5, we need some uniformity with respect to $a$ in Theorem 6.6, which is not given by the above statement of that theorem; but provided we change $m^{-5 / 4}$ into $\sqrt{n} m^{-5 / 4}$ in $R_{m}$, a careful examination of Fejér's proof of Theorem 6.6 shows that this uniformity holds. Alternatively, write $c_{m}(a)$ as a Fourier coefficient

$$
\begin{equation*}
c_{m}(n)=\frac{1}{\pi} \int_{-\pi / 2}^{\pi / 2} \exp [i(n \cot x+2 m x)] d x \tag{6.4}
\end{equation*}
$$

and use the previous van der Corput estimates.
Once this lemma is at our disposal, we can prove again the following theorem.
Theorem 6.7. Assume that $\beta$ is a non-increasing sequence and that the composition operator $C_{I_{1}}$ maps $H^{2}(\beta)$ to itself. Then $\beta$ satisfies the $\Delta_{2}$-condition.

Proof. Our assumption implies, with $M=\left\|C_{I_{1}}\right\|^{2}$ :

$$
\begin{equation*}
\sum_{m=0}^{\infty}\left|a_{m, n}\right|^{2} \beta_{m} \leq M \beta_{n} \tag{6.5}
\end{equation*}
$$

We use Lemma 6.5 with $C^{-2} n \leq m<n$, where $C>1$ satisfies $C \sqrt{2}<$ $\pi / 2$, which is possible since $2 \sqrt{2}<\pi$. The term $R_{m}(n)$ is dominated by $K C^{-1 / 2} m^{-3 / 4}$. Let $\theta_{m}=2 \sqrt{2} \sqrt{n m}+\pi / 4$ be the argument of the number appearing in (6.3). We have

$$
\theta_{m+1}-\theta_{m}=\frac{2 \sqrt{2} \sqrt{n}}{\sqrt{m}+\sqrt{m+1}}
$$

hence

$$
\sqrt{2} \leq \theta_{m+1}-\theta_{m} \leq C \sqrt{2}<\frac{\pi}{2}
$$

The argument $\theta_{m}$ then varies not too fast, and there is a positive constant $\delta$ and a subset $E$ of integers in the interval $\left[C^{-2} n, n\right]$ such that $|E| \geq \delta n$ and

$$
M_{m}(n) \geq 2 \delta n^{1 / 4} m^{-3 / 4} \geq 2 \delta n^{-1 / 2}
$$

for all $m \in E$. Therefore, for $n$ large enough, we have, for all $m \in E$ :

$$
\left|a_{m, n}\right| \geq 2 \delta n^{-1 / 2}-K \sqrt{n} m^{-5 / 4} \geq 2 \delta n^{-1 / 2}-K C^{5 / 2} n^{-3 / 4} \geq \delta n^{-1 / 2}
$$

With this information, (6.5) gives:

$$
M \beta_{n} \geq \sum_{m \in E}\left|a_{m, n}\right|^{2} \beta_{m} \geq \delta^{2} n^{-1}|E| \beta_{\left\lfloor C^{-2} n\right\rfloor} \geq \delta^{3} \beta_{\left\lfloor C^{-2} n\right\rfloor}
$$

where $\lfloor$.$\rfloor stands for the integer part, and this proves the theorem.$
